## CONCESSION RULES

The concession agreement is based on the attached application and set of Rules. This concession agreement is between: CANDO, Inc. ("Host") and \_\_\_\_\_, (Vendor). It is established that Vendor will participate in the **2019 Tampa Bay Caribbean Heritage Month Festival & Fund Raiser Event at The University Area Community Development Center 14013 North 22nd Street, Tampa, Florida 33613 on June 1, 2019.** Vendor agrees to adhere to the following rules as terms of this agreement. It is the responsibility of the vendor to maintain proper license, permits, and insurance; copies of such made available to the Host upon request.

1. Gates will be opened for SET UP, Saturday June 1<sup>st</sup> at 10:00 am. We expect all Vendors to arrive and complete set-up no later than 2:30pm.
2. Failure on the Vendor's part, to abide and cooperate during the event will result in the immediate ejection from the Park; with the understanding that there will be **NO REFUND**.
3. Vendor's concession area is to be set-up and staffed, 30 minutes before the gates open at 2:00 pm.
4. All vehicles will be directed by Security on where to park, prior to the scheduled opening or will be removed from the Park. No exceptions.
5. Vendor agrees to meet all financial obligations to CANDO, Inc **prior** to set-up in the park.
6. Vendors will be provided with 1 table and 2 chairs.
7. Vendor will be provided with standard tent space of 10x10 with electricity (110) and water access.
8. Vendor will provide their **own** equipment and fixtures needed to facilitate their concession. No stakes of any kind will be permitted to stabilize the tents or penetrate concrete deck.
9. Vendor shall operate their concession in a safe, orderly, and sanitary manner and in accordance to local and state regulations.
10. No pets allowed in the park - leashed, caged, or otherwise, with the exception of service animals
11. All business, marketing, and sales must be conducted within the contracted tent/concession area.
12. No loud or amplified music allowed from any Vendor's tent or area; no exceptions.
13. Tent signage can only pertain to the concession's service or product approved in the application.
14. Vendor's sale items are limited to the approved items in the application.
15. No abusive, profane, obscene, or threatening acts or conduct will be allowed by any vendor.
16. All vendors are responsible for the disposal of their waste. Any vendor caught disposing their waste outside of the proper trash receptacles will be ejected. Washing of pots, pans, grills, etc. in or near storm water drains will also be ejected, and possible fine by the city/county.
17. Food vendors cooking on the premises must have a working Fire extinguisher.
18. Vendor must post license in an inconspicuous area of the tent during the event.
19. Vendors are prohibited from selling Beer, Wines or other alcoholic beverages, except for CANDO, Inc.
20. Breakdown and removal of equipment, fixtures, and tents must be completed by 9:00 pm, Saturday June 1<sup>st</sup>, 2019.
