

## Board Highlights

February: The regular meeting was held Sat. February 12, 1994 at the Snug Harbor Clubhouse at 10:00 a.m..

A junk car ordinance has been implemented by Chowan County. Mr. Mizelle will determine if the item is on the agenda for Perquimans County and work with them to secure an ordinance in our county.

Mr. Cullings will have a permit renewed for repairs to the F-Section bulkhead and get bids for the work.

A need for recreational facilities for younger children was discussed. Mr. Mizelle is to get information on a facility in Virginia that was constructed with donated supplies and materials. More info will be forthcoming.

A discussion of activities related to the Park area was held. It is a priority of the Board to make better use of the Park area.

The Board received a sample of governmental documents for restrictive covenants. It was agreed these are good guidelines for the Association in considering covenant revisions.

March: Mr. Mizelle presented a preliminary draft of the revised covenants which were discussed. He will present another draft at the next meeting. Mr. Cullings gave a detailed report on maintenance items concerning Snug Harbor. Details are in a separate article under "Maintenance News". Mr. Cullings is obtaining bids for repair of C-Section boat ramp, F-Section bulkhead & ramp, and bulkheads in the Park.

It was decided to restore electricity to P-Section on April 1, 1994

The Treasurer, Mrs. Millirons, reported that assessments/dues, due March 31st, are being received and processed.

#### **Maintenance News**

I have been requested by Snug Harbor Property Owners Assn. member, Frank Edmunds, to contribute a report for our newsletter concerning ongoing maintenance items in Snug Harbor. It is our view that communication is vital to our neighbors so they know what the Association is attempting to accomplish.

During the month of February, we have been busy attempting to drain, grade, and fill the numerous soft spots in our roadways that have been damaged by vehicular traffic. Most of the damage has not been caused by autos but by trucks and school buses. As of this date we feel that we have been able to get most of the trouble spots corrected. For some of our neighbors, roadway shoulders were damaged by tree trimming crews subcontracted to Albemarle Electric Cooperative. I Have been assured by the Co-op that these damaged areas will be corrected. We need to be patient until the ground begins to dry.

Speaking of wet, how about the rain storms that filled ditches to overflowing and probably flooded some of your homes. I might add to this item that we all need to be cognizant of debris left in the ditches on our property and our neighbors property. Due to leaves, branches, and in some cases bottles and trash, the culverts and tile became plugged, thereby backing up water and preventing the outflow of drainage. It was good to see some neighbors out helping others so that ditches were cleared. Let's remember that if we keep it clean, then the task is not so great later on when leaves begin to fall.

Repairs have been done to the roof of the comfort station in "P" Section and by golly, it survived the deluge and stayed dry. Now we will get the ceiling repaired and painted.

Clean up is commencing in the park so it will be looking nice as spring arrives. We have sent out 4 grills for repair so that families will be able to utilize all of the grills for cooking. The picnic benches are virtually new so the park should be a great facility for family and group get-togethers.

That's the highlights for the month. Other items are slated for consideration as bids are received and funds become available. Neighbors, we are trying! If we had a bank full of money we could do wonders, but with limited funds available to us, we are being very careful how we spend your money. Remember to send in your annual dues! 


