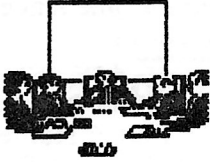

Board Highlights

February: Resignation of Mr. Roy Brewster, Secretary of the Board was accepted with regrets. A letter will be drafted to the County Commissioners supporting a junk car ordinance. New Fire Code Regulations pertaining to the Clubhouse require posting capacity and installing lighted Fire Exit Signs. New State Pool Regulations have been received and are being examined for compliance.

March: Mrs. Barabara Bland was selected by the Board to fill the vacancy of Secretary. Mr. William Toney was elected to fill a vacancy on the Board. It was reported that some attorneys are sometimes failing to cite the existance of the Covenants in deeds. Our lawyer advises that they apply whether cited in the deed or not. We are happy to report that Assessment collections thus far for this year are ahead of previous years. It was reported that the Feb. 27th dance was a success. Mr. Toney donated the money to pay the band.

April: Membership in the local Chamber of Commerce was renewed for 1993. Recent storms have brought down trees and power lines with P-Section being hit the hardest. Some were without power for 23 hours. Most repairs have been completed. The maintenance vehicle was nearly destroyed by an electrical fire. The Clubhouse lost most of the front roof shingles but most all the cost of replacement will be covered by insurance (but not all).

Trash Disposal

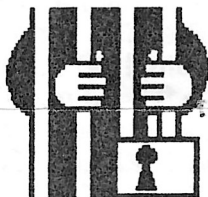

Crime Watch Report



Crime Watch and Disaster Program recently had a guest visit from Sheriff Joe Lothian. Joe shared with us information about the operation of the Sheriff's Department, discussion of problems they encounter and ways residents can help the officers in their duties. He also answered numerous questions from residents in attendance concerning criminal firearm violations, drug and alcohol complaints in Snug Harbor, and problems with trespassing and noise violations in our community. Discussions also included concerns about dogs running loose frightening children, walkers and bikers. Officer Lothian discussed the need for residents to call the Sheriff's Office to make an anonymous report if necessary to report information on drug or alcohol abuse activity. Recent drug raids have increased the need for drug users to change places of pickup and delivery and bases of operation.

The recent Harvey Pt. Rd. murder and murder of the Elizabeth City 21 year old drug related cases reminds us that we have people here in our community who may also be involved with deals looking for a place to do business. Don't be too easy and make drug dealers and users feel at home here - - Call the anonymous call if you can! Be cautious of unusual people activities or vehicles, and be cautious of people looking for money without giving a fair service in return, or people begging money from senior residents or incapacitated persons here in the community. Don't support their drug habits - - again, call the police. Holiday Island is also being warned of this type of activity

We continue to meet the 2nd Tuesday of every month at 7:30 p.m. at the Clubhouse. Our next meeting will be May 11th. Please attend and bring a friend. This meeting will also be discussing the community disaster plan, so come bringing your ideas.

Snug Bugs, Magellan's Crew and Teens-in-Action continue to meet regularly and lots of activities are still planned!

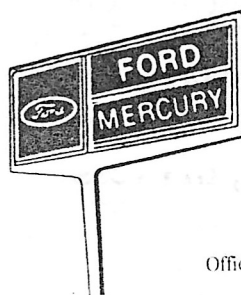

Note to P-Section Owners

At the last November annual meeting and in the last newsletter I noted that covenants for all sections of Snug Harbor are in need of revision, particularly those for P-Section.

One of the things making revision of the P-Section covenants urgent is the presence of full-time, year-round campers who consume electricity in winter months costing more per month than their total annual assessment. The covenants do not prohibit this and the Association is required to pay the bill. This money comes from P-Section funds which are inadequate for this type of expense. Two solutions are possible. Raise assessments of all P-Section owners to bear utility costs caused by one or two campers or, change covenants so that year-round utilities need not be provided. All P-Section owners that I have talked to so far favor the latter course. Note that individual electrical services are not possible due to State Utilities Commission regulations.

The latest draft of revised P-Section covenants would, if ratified by half or more lot owners, include provisions as follows:

- ~ allowable uses of camping lots would not include permanent residence;
- ~ no permanent structures except porches and storage buildings would be permitted;
- ~ types of permitted camping accommodations would be better defined;
- ~ assessment procedures would be revised to describe those currently in effect;
- ~ electricity and water would or provided to the comfort station all year and to individual lots only during the camping season, May through October.

I have discussed these revisions with P-Section owners who have been available during winter months and am available to discuss them with any other owners. You may have a better idea. Our common objective should be to maintain an area for camping which is safe, clean, attractive and affordable. It will take an affirmative vote by owners of at least half of P-Section lots to make amendments which are necessary to reach this goal.
