A special meeting was called by your board of governors for September 18, 2010 @ 9:00. meeting is a result of the lawsuit filed against our association and five 2009 board members by Mrs. DeWeese and Mrs. Klasing. This meeting is a result of our legal council's recommendation to minimize further impact upon this association from within community. A vote was taken by the membership to either retain or remove Mr. William Toney Jr. from the board of governors and I'm pleased to announce that Mr. William Toney Jr. has been retained as a board of governor with a vote of 460 to retain and 132 to remove. He is a valuable asset to this community and one of our hardest working board member. Concerning this lawsuit; remember that this board of governors' first and foremost duty is to seek what it deems is in the best interest of the Snug Harbor Property Owners Association. This lawsuit will cost this association in excess of \$6,000. This unforeseen expense is yet another circumstance for the increase in 2011 assessments. After several budget sessions, the board has determined that the 2011 assessments need to be increased from \$85.00 per lot to \$89.00 per lot to bolster our capital reserve fund for maintenance projects.

#### **Camping Section News**



The Snug Harbor Board of Governors has worked hard to improve the Camping section this year. We have purchased a box blade with which to level the dirt roads and have used it on Camping section roads with great success and will continue to use it to help keep the roads in much better repair. In addition, we installed vent fans over the showers in the comfort station to remove moist air from the showers and help to reduce the amount of mold and mildew in the shower areas.

In an effort to reduce utility costs in the comfort station, a couple of owners who use the facilities in the wintertime have proposed closing the men's room in the winter and opening the ladies room as a unisex bathroom during the coldest months and shutting off heat and water to the men's side. This appears to have some merit and I have discussed this with some campers and have not found any objections so far. I would like to propose that we closed the men's bathroom at the comfort station from December 1 until March 15 which is just after the beginning of Lent next year and use the ladies room as a unisex bathroom. If any campers are using the facilities in that timeframe and have any serious objections to this I would like them to get back to me.

Currently the Snug Harbor Property Owners Association owns two lots in the camping section, P-9 and P-30. The Board is willing to accept reasonable bids for the purchase of these lots and bids should be submitted under sealed bid to the Board for their consideration.

For over two and one-half years I have served and along with 8 other board members tried to maintain our common property and be conservative with the membership's money. I led the initiative to buy our own mower and cut our grass, which saved us \$4,000 the first year, and more each following year. I worked with Mr. Toney to manage the park/pool operations saving about \$7,500 per year. We have nine very different members on the board and I can wholeheartedly tell you that we have the best intentions for our membership. We don't always agree and usually good discussion occurs, but there is no pounding on the table or name calling. The end result is we try to do what is best for Snug Harbor and listen to the membership. I also led the effort to purchase a new copy machine for the office which has greatly automated our printing, saving SHPOA considerable printing costs and valuable office time. This year we were faced with two unbudgeted expenses, unpaid taxes on a piece of property sold several years ago and a lawsuit against SHPOA costing over \$6,000. No one wants to raise assessments, but it became necessary, to meet our 2011 budget and return money back to our reserves. The lawsuit is not only expensive, it takes money away from needed projects and time away from doing important SHPOA business. Again, I ask for your vote, and will continue working for our best interest. Thank you for your support.

#### Mr. William Toney Jr.

I have worked hard for the last three years serving as your association secretary, operational manager of the park and pool summer program, and co-chair of the aesthetics committee. I've updated and automated the office and saved over \$3,000 by soliciting advertising and printing one of the best Newsletters around. As your park/pool operational manager I've worked with community watch and Sheriff Tilley to keep drugs off our property and saved over \$20,000 that SHPOA would have paid to contract this position. Some might say I must be crazy to want to continue on, after everything my family and I have been through. I still believe this job is about serving our wonderful community and listening to all the membership to make all of Snug Harbor a great place to safely raise our families, enjoy retirement, and take advantage of some super water recreational activities. I would greatly appreciate your continued support.
