LETTER FROM THE PRESIDENT

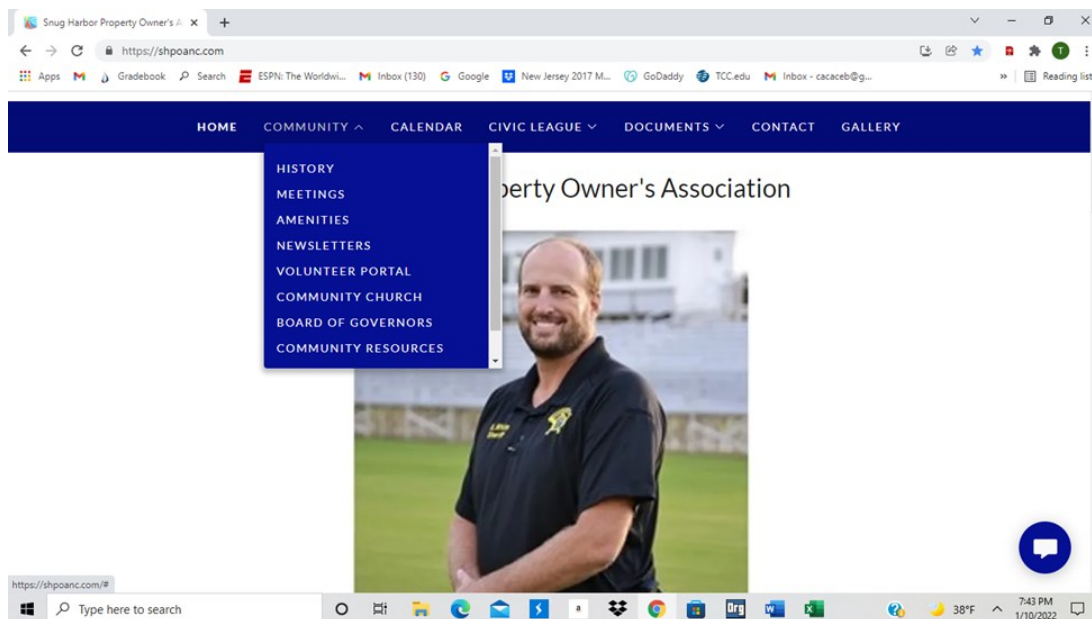
Hello and Welcome to 2022!

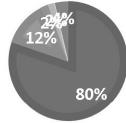

2021 Annual Budget

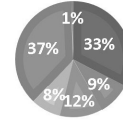

Pool Tag Policy Update

The Pool Tag Policy has been updated, is posted on the website at <https://shpoanc.com/policies-and-procedures> and includes the following statements:

If a property owner is on a payment schedule and continues to be timely in making payments, they have the right to pool, park and boat ramp privileges.

If a property owner loses their "Good Standing" status throughout the pool season, they and their guest will not be allowed those privileges.

P Section Announcement

The Board of Governors would like to schedule a meeting with **P Section Owners on Saturday, March 12, 2022, at 11:00 am**. The Board of Governors Monthly Property Owners Meeting will be held that morning at 9:00 am.

This P Section Owners Meeting is to have a conversation about ideas to clean up the camping section and how to make sure all owners have a voice in what happens in that section.

Please plan to come and meet with the Board of Governors and let us know your concerns and how we can work together to make the P Section better.

POLICY REMINDERS

Aesthetic Policy States:

A) Regular grass cutting, trimming of shrubbery and lawn, raking of leaves, and general yard maintenance. Owners are encouraged to maintain their yards to the road to assist water drainage, help control mosquitoes and to keep Snug Harbor looking beautiful.

B) Any structure, building, mobile home, storage facility or other real or personal property will present itself in good working order including exterior surfaces maintained in uniform and good repair. All windows, doors, porches, screens, steps, skirting, decks docks, sheds, fences, and garages will be in good working order. Boarded up door (s) and windows are not considered to be in good working order. Tarps will be used as an emergency repair measure only and are not acceptable as a permanent repair.

C) No junk, abandon or nuisance automobile, truck, trailer, boat, or recreational vehicle shall be permitted to remain on the property.

D) No “unsightly materials” will be stored on the property.

E) Outside household trash and garbage shall be maintained in sturdy and covered containers, as inconspicuously as practical and they shall be emptied regularly.

Architecture Policy:

Property Owners must complete an Architectural Application for any and all property improvements. Most improvements, to exclude fences, will need this application approved by Snug Harbor SHOPA, Architectural Committee. This application will need to be completed prior to going to the Health Department, Zoning, CAMA, and the Building Inspectors for permits. Once the application is approved by SHOPA, a copy will be placed on file and the Property Owner will receive the original with the green copy which will be turned into the Building Inspectors Office. Once the project is completed, you will then notify SHOPA to finalize the application.

ATV's, Motorcycles, Side by Sides or any other Offroad Vehicle

All Property Owners, Renters etc., the above-named vehicles are prohibited from state-maintained roads, (paved roads), for any type of recreational use.

It has come to the Board of Governors attention that these types of vehicles are being utilized by unsupervised youth as well as adults, without wearing the proper safety equipment. If these types of vehicles are being utilized, they must be properly licensed and tagged.

Assessments

Assessments are mailed at the beginning of each year (mailed on Jan 5th this year) and are due by February 28 to avoid a late payment fee (\$25 per lot). If you did not get your assessment, you can call the office and request a copy to be emailed. It is your responsibility to make sure SHPOA has your correct mailing address. Also, a reminder that if not paid timely, Snug Harbor will begin filing liens on delinquent property owners in March. All liens are subject to a \$50 filing fee which will be applied to your account. Please contact the office to discuss a payment plan to help you manage your fees. We are interested in working with you on this matter.

SHERIFF SHELBY WHITE

Presentation and Question and Answer Session

January 11, 2022 at Snug Harbor Clubhouse

We had a great turnout for the Sheriff's visit. Here are some of the topics covered at the meeting, starting with the issues the Sheriff's Department covers:

Sex Offender Registry: (<https://www.nc.gov/services/sex-offender-registry>) Department checks once a year to verify they are still living at the address listed

Pistol permits including concealed permits

Serves official papers as required.

Answers public service calls. In 2021 answered 11,570 (1,000 more than last year).

Main crimes in the county right now are scams and fraud. This can be by email, mail or phone. If you suspect something call the Sheriff's office, they can help detect if it is a scam or fraud.

Sheriff Department now serves the City of Hertford through a contract. Department gained 6 additional officers (24 total) who serve the entire county.

Topics from the Community:

Animal Control - The Animal Control Officer is to enforce the county and state ordinances, laws and resolutions related to animals.

ATV's – UTV's – Dirt Bikes - Motorcycles - If you have a license plate on the vehicle, you can drive on state roads, but not down the highway. If not licensed (ATV's) are illegal on state roads. Golf carts are okay on side roads, but should not be on main roads. Kids are not allowed to drive ATV's, UTV's, and motorcycles without a drivers license, helmets and insurance. Anyone in ATV's must wear a helmet.

Speeding in Snug Harbor – the Sheriff's office will notify Highway Patrol as well as monitor our roads.

Drug problem in Snug Harbor - Drugs are a concern all over the county. Arrest have been made.

Do vehicles need mufflers? Yes they do.

Issues in Snug Harbor? Crime has dropped and there has not been any major issues lately.

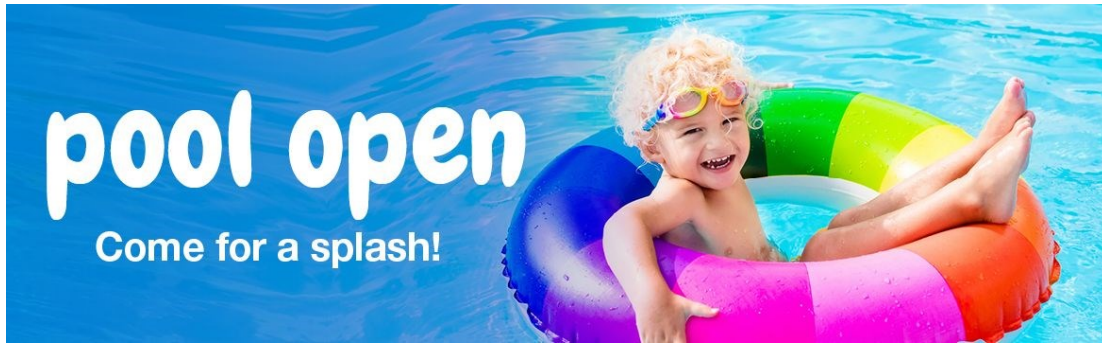
