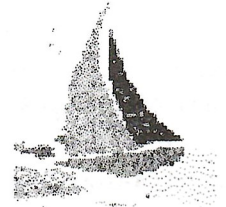

## USE AND RENTAL OF THE CLUBHOUSE

On October 23, 1997, the Board adopted a policies and procedures statement for the use and rental of the clubhouse. Briefly, it states that any Association member in good standing may use the clubhouse. Normally, no fee is involved if the use involves only Snug Harbor resident/owners. A schedule of fees is provided for other uses, as well as a rental/use form.

Minor modifications of the policy and procedures have been suggested. Prior to adopting any changes to the current statement, the Board wishes to give all Association members an opportunity to comment and/or provide input. This may be in writing, addressed to the Board, or during the April 11th Board meeting during which revision to the statement will be considered for adoption.

Copies of the existing and proposed revised statement are displayed on the bulletin board in the parking lot. Copies are available in the clubhouse office.

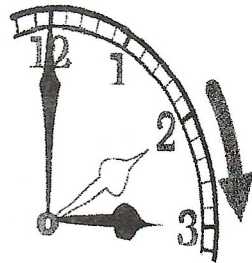

## Snug Harbor Community Watch News

At our January meeting, Sheriff David Lane of Perquimans County presented information on how to improve security around our own homes.

Most important is, where do you live? Is your property clearly marked with your lot number? The Fire Department, Ambulance or Sheriff's Deputies may need to find you one day, perhaps in an emergency. A sign in your front yard or on your home giving the lot number can be a big help. A sign on your mail box will help only if yours is the only mail box in front of your lot. Help yourself, post your lot number.

Yard lights are a big safety and security device. Install one yourself or ask the Albemarle Electric Company to install a yard light for your home, the monthly cost is low. Other bright lights around your home also discourage trespassers; and also lights on timers that turn on and off even when you are away, are a deterrent to crime. If you have bushes around your house, cut them low around windows to reduce shelter for a would-be trespasser. And lock your doors. Use deadbolt locks for best security. Your hardware store has good locks available. If your windows do not lock well (or sliding glass doors) drill a hole and put in a nail from the inside through both frames to keep anyone from opening the window from outside, you can easily remove it if necessary. All these are things that you can easily do to improve your own security.

Finally, and most important, if you need help, call 911. Your Sheriff David Lane promises you quick response. He appears frequently at our meetings, personally patrols regularly at Snug Harbor along with his deputies, and he and his team are responsible for taking into custody six men who were involved with six breaking and entering cases in a six month period here at Snug Harbor. Items stolen have been returned to their owners, including the VCR which was taken from the Clubhouse.

Help protect your community property here at Snug Harbor. Drivers of autos, trucks and 4 wheel drive vehicles have been tearing up the parking lot with their tires, and driving recklessly and at high speed on our Clubhouse parking lot, at Beaver Cove, and on our roadways. Write down the license number and call Community Watch or the Sheriff or the Highway Patrol. Save our roads and parking lots from damage, and save yourself from the threat of reckless drivers.

We need to work on patrolling or monitoring of the park this coming summer season to ensure that everyone who wants to enjoy the park can do so. If you have ideas or want to help, or if you want to relate problems that you would like solved about the park, please contact your Block Captain or call me.

Your Community Watch is interested in your security and the collective security of all of our Snug Harbor community. Call your Block Captain or your Chairman if you need help with a problem or want to be a part of our organization. Attend our meetings, the third Tuesday of each month at 7 PM: the next is Tuesday March 17, and the next is Tuesday April 21. Hope to see you there. We need your help and active participation.
