President's Letter

Welcome to Spring 2023.

The Board has been busy with new ideas and projects. We are working to set up another community meeting with the Sherriff, EMS and Hertford Volunteer Fire Department to understand their goals for 2023 and allow you to ask questions. We are also hoping to have Rachel Gunther from Gunther Law Group in Hertford come and talk about Trusts; specifically, what they are and how they work, as well as a Q&A time for you.

Recently, I've heard questions about how the SHPOA board works. I'll try to answer those specific questions below, along with providing an overview of the differences between board members, the Civic League, as well as paid positions of SHPOA. Just know that you can always reach out to a board member to get clarification if needed and/or you can check our official site at shpoanc.com to read the Covenants and/or Bylaws

<u>The Board of Governors</u> is comprised of nine volunteer members. Board members are not compensated for their board-related work. The BOG is an all-volunteer working group. I'll elaborate on this later.

The BOG is governed by the Articles of Incorporation, Bylaws and Covenants. The board members are voted onto the board for a term of three years. Each board member can be voted on to serve a second term of three years, then they must rotate off the board. Board members are voted on at the Annual Meeting, at which time we review the process for voting and counting votes. That information is posted on the slides from the annual meeting to the Snug Harbor Property Owners Association website. All members in good standing get one vote based on the number of lots owned that can be applied to each of the three nominees. For example, if I own two lots I get one vote per lot or a total of 2 votes per candidate.

The exception is filling a vacancy:

"Vacancies on the Board of Governors shall be filled by a vote of the majority of the remaining governors and a person so elected shall be a Governor until his successor is elected at the termination of the filled term of office." Bylaws – Article VI – Section 5. Vacancies (page 5)

The job of a Board is two-fold. One role is policy making and the other is administration. In setting policy, the Board decides what it wants to accomplish while administration is finding ways to carry out the policy.

After the election, the current Board of Governors determines the role of each officer for the following year.

The Bylaws state that there will be one Annual Meeting a year for members. For many years, the Snug Harbor Board of Governors has held monthly Association meetings open to all members. This gives members the opportunity to hear about the work of the Board and to ask questions or voice concerns.

The Bylaws also state that the Board of Governors will hold a regular meeting minimally once every two months during the fiscal year. The Snug Harbor Board holds a meeting every month referred to as a Workgroup meeting for the Board, in addition to the monthly

Association meeting.


- Office Manager all 12 months

Policy change included in Assessment Letter about Clubhouse Rental Changes. Call or stop by the Office for a copy of the updated policy.

a. There is a \$ 100 dollar deposit and a \$150 rental fee for the clubhouse common area rental. The deposit will be forfeited if the clubhouse and common area is not left in the condition that it was found. The fee will help cover the cost of building maintenance, paper supplies, use of tables, and chairs (and replacements as needed).

b. Smoking is not allowed in the clubhouse. Consumption of alcoholic beverages is only allowed in the Clubhouse with prior approval and appropriate insurance coverage.

BETHEL VOLUNTEER FIRE DEPARTMENT

In 2022, your Bethel Volunteer Fire Department devoted many hours to training and meeting documentation requirements to obtain the best Fire rating in the history of the department. The Office of State Fire Marshall (OSFM) rates the department on the ability to reach the destination and get water to the fire. This process was tested and rated by OSFM. Prior to training their rating was a 9S. A rating of 10 means there is No fire service at all. On September 13th, the OSFM Deputy State Fire Marshal awarded the new rating of CLASS 5/9E. This new rating affected us here in Snug Harbor, by showing how well our Volunteers are prepared for responding to calls and battling fires in our district. This means new lower insurance rates for us all as of December 1, 2022.
