Board Highlights

April Meeting - A handicap ramp has been constructed at the clubhouse front door. Roof at rear of clubhouse has been repaired at cost of \$4,897. Yard of the Month awards resume in April. A member requested that his two lots be assessed as one since County combined them for tax purposes. Attorneys's advice was that County tax action does not supercede platted lot information.

May Meeting - A young lady gave the Board a report of youth's perspective and concerns for our community. Pool has been cleaned with assistance from several community members. Yard of the Month has been awarded to Davenport, McKenzie, Bullmore and Ware residences. Members complained that an owner has failed to remove trees fallen from his lot that block a canal. Board voted to advise the owner that trees would be removed and lien placed on his lot for cost involved. SHPOA now is owner of lot G-55 which is available for sale.

June Meeting - The Board was advised that leadership of the Community Watch program has passed to Floyd Friesen (See article elsewhere in this issue). The Board resolved to thank Marq Gray for his many years of service to the community in organizing and leading the Community Watch almost continuously since he founded it. The Board received a complaint concerning use of residential lots in H Section as camping lots, which is a violation of Covenants.



PURPOSE: To provide for the safe use of the social and recreational facilities and properties; To ensure the equal use and enjoyment by the members; To provide for the safety of members, their families and authorized guests; AND To establish minimal standards and guidelines governing users of the pool facilities and clubhouse area.

POLICY:

- Members are responsible for observing all pool rules and regulations and are to insure that their guests observe all rules and regulations.
- Parent (members) are responsible for the conduct and safety of their children. Parents shall insure their children observe all rules and regulations.
- Members sponsoring group activities are responsible for the conduct and compliance with the rules and regulations by all members of the group
- CHILDREN UNDER AGE 12 must be supervised by a responsible adult member
- ALL SWIMMING IS AT ONE'S OWN RISK

PROCEDURES:

USE OF POOL:

Identification tags are required for entry to the pool area. The tags have elastic bands are to be worn at all times while in the pool area. ID tags can be obtained for one dollar (\$1.00) from the clubhouse during normal office hours. Owners are encouraged to purchase extra tags if they expect frequent guests.

ADMITTANCE TO THE POOL:

All persons using the pool facilities are required to enter their name, ID tag number, and lot number in the log book located in the immediate pool area. The log book is to be signed each day the pool is used.

Tags shall not be loaned to any person, family member, or guest of any owner, whose assessments are in arrears.




GENERAL SAFETY REQUIREMENTS

THE POOL IS FOR THE ENJOYMENT OF EVERY AUTHORIZED USER. Please be courteous to everyone at all time while in the pool area. Improper conduct may be grounds for dismissal from the pool and withdrawal of pool privileges.

FOR EVERYONE'S SAFETY AND HEALTH PLEASE OBEY THE FOLLOWING RULES

- BATHING SUITS ARE REQUIRED
- DO NOT SWIM ALONE-USE THE BUDDY SYSTEM
- RUNNING IS NOT PERMITTED
- GLASS CONTAINERS ARE NOT ALLOWED IN THE POOL AREA
- NO BABIES IN DIAPERS ARE ALLOWED IN THE ADULT OR KIDDIE POOL
- FOOD IS NOT ALLOWED IN THE POOL AREA(except by special approval of the Board)
- ONLY SMALL WATER TOYS OR INFLATABLE TOYS ARE PERMITTED
- ALCOHOLIC BEVERAGES ARE NOT ALLOWED
- NO PETS OR BICYCLES ARE ALLOWED IN THE POOL AREA
- ABSOLUTELY NO PROFANITY OR DISRESPECTFUL BEHAVIOR WILL BE ALLOWED
- PROPERTY DAMAGE IS THE RESPONSIBILITY OF THE RESPONSIBLE MEMBER
- ALWAYS FOLLOW THE POOL ATTENDANTS INSTRUCTIONS


