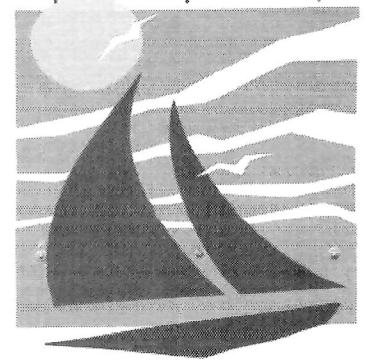

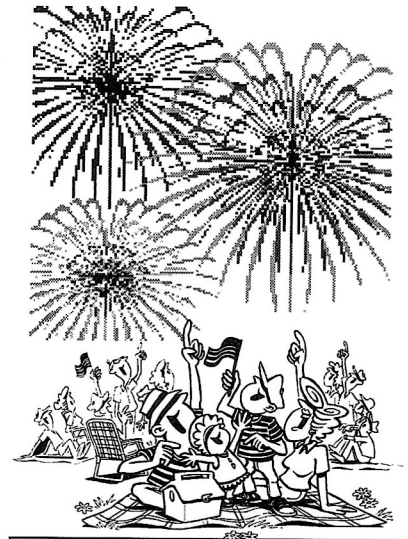
President's Corner

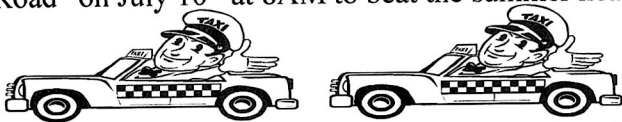




Civic League Corner

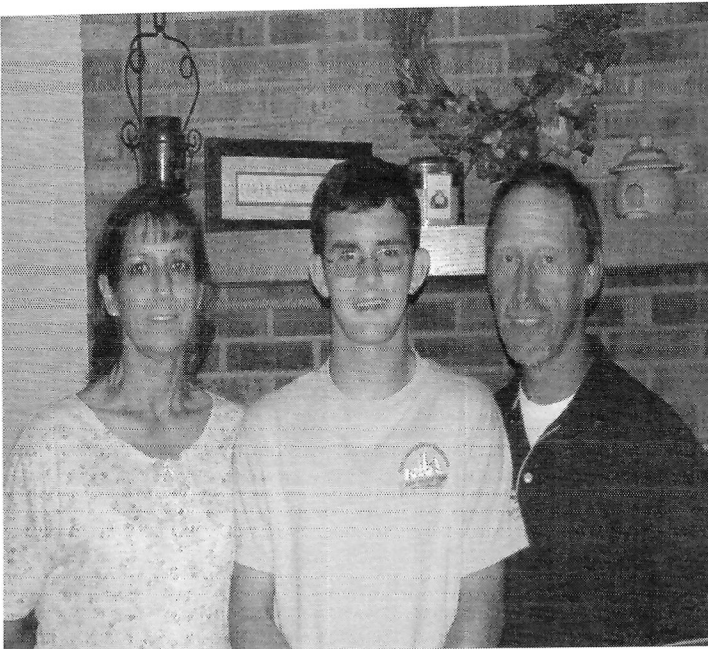

Clayton Harris wins Albemarle EMC Washington Tour Contest

Snug Harbor's very own Clayton Harris, the son of Sherry and Jim Harris, was recently selected Albemarle EMC's Washington Youth Tour contest Winner. Clayton, an 11th grade student, was selected from a pool of candidates in a 5 county area based on the quality of his essay and his academic achievements. His essay explored future energy sources and was titled "The Power of Tomorrow." He currently takes honor classes and is a member of the JROTC drill team and Student Government Association. Clayton was also the runner-up among all the North Carolina winners in an additional Youth Leadership competition speech. He joined 1500 other winners from across 38 states meeting with elected officials and touring the Tomb of the Unknown Soldier, Smithsonian Museum and Mount Vernon. The visit also included a trip to the Kennedy Center, a boat ride down the Potomac and a dinner dance. Clayton said the best part of this trip was laying a wreath at the tomb of the unknown soldier and standing where Martin Luther King gave his "I Have A Dream" speech.

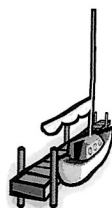

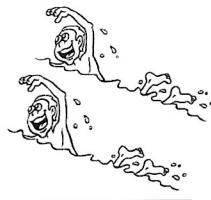

Park & Pool News



Pool Tags can still be purchased at the SHPOA office on Tuesdays 10AM – 3PM and Saturdays 10AM - 3PM. All property owners in good standing are authorized to purchase annual tags for those members of their immediate family that reside with them. An additional two annual pool tags may be purchased for guests. **Guest passes may not be given to delinquent owners or their immediate family that reside with them because their assessments have not been paid or they owe SHPOA money.** Tenants are reminded that they must have the “Renters Pool Pass Application Form” which is available at the office, filled out and signed by their landlord prior to purchasing pool tags. Children are not allowed to purchase pool tags. **Annual tags will only be sold during office hours! So please plan ahead and get your pool passes when the office is open.** Pool attendants can only sell daily tags. If you are entitled to annual passes and have to purchase daily passes, the cost of daily tags will not be deducted from the cost of the annual tag.

SHPOA hired 3 pool and park attendants and they are Mrs. Mae Lawson, Mrs. Connie Askew, and Mrs. Violet Sheldon. They are stationed at the pool and park for your safety so please follow their instructions.

2010 Pool Hours The pool will open from 12:00 Noon to 8PM Tuesday through Sunday.

To use the pool, you must have a SHPOA pool tag (Annual or Daily). Parents are reminded that no child age 12 and under will be allowed into the pool area unless accompanied by an adult, age 18 or older. The ladies’ water aerobics exercise group plans to again hold sessions this year Monday through Friday at 9 AM. Please help us in the park by cleaning up after your dog, so children don’t have to step in feces.

Covenants, Bylaws And Assessments



Work on updating and revising the Snug Harbor Covenants continues with former and present SHPOA Presidents meeting and discussing ways to improve the 1995 covenants. Improvements for the new covenants center on the idea of making the document more resident friendly, understandable (less confusing) and current in keeping with North Carolina and Perquimans County Law. It has been an arduous task but one that will significantly improve the governance of Snug Harbor. It is hoped that the document will be ready to be shared with residents this fall.

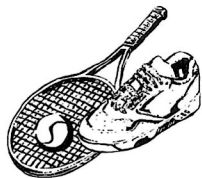
A reminder to those property owners who have not yet paid their assessments for the year 2010. If your Assessments were not paid by the last day in February, 2010 a \$25.00 late fee has been charged to your account. In addition you will be assessed a 6% per annum interest charge as of March 1st, 2010. According to our Policy Statement liens will be filed in the Perquimans County Clerks Office starting June 1st, 2010. If you are not certain whether you have paid your assessments, or you have misplaced your invoice giving you the amount owed, please call the SHPOA Office for clarification. Our office is open on Tuesday’s and Saturday’s from 10:00 to 3:00. The phone number is 252-426-5172. Your SHPOA Board is very aware of the difficult economic times many of our residents are enduring. If you would like to speak with me regarding your assessments, feel free to call me at 252-426-7136. Please make an effort to pay you 2010 assessments and join the 87% of property owners who are current with their assessments.
