The immigration of Kotters Heinrich Kleinhackenkemp, called Plassmeyer, and his wife and six children:

Dear Mr. Plassmeyer:

After a long search and investigation we are able today, to give communication, who your predecessors were, where they came from and who emigrated to the United States.

The name Plassmeyer descended from Benteler. The place Benteler was till the end of the ninetieth years of the last century, rural community of the place Wadersloh, and also belonged ecclesiastically to Wadersloh.

The Kotterfarm Nr. 39 in the rural community Benteler belonged to Plassmeyers. The last real Plassmeyer died on the 25th of August 1834 and left his wife, which was blessed on body.

Anton Plasmeyer, Kotter, Benteler 39: born, 30th of January 1809 in Wadersloh, Christened, 1st of February 1809 in Langenberg, died, 25th of August 1834 in Wadersloh.

The wife's name of this Anton Plassmeyer was Elisabeth Heckenmeyer, she gave birth to a girl, Margareta after the death of her husband, but it soon died.

Wedding: Anton Plasmeyer and Elisabeth Heckenmeyer 6. 11. 1832 in Wadersloh.

Child: Margaretha, born Wadersloh 7. 9. 1834, christened, 8. 9. 1834 in Wadersloh, died, 16. 11. 1834 in Wadersloh.

The widow of Anton Plasmeyer now married on 10. 2. 1835 Johan Henrick Nienkemper, see the added register out of the wedding register at Wadersloh. This Johan Henrich Nienkemper takes over from his wife, the widow Plassmeyer, the

This Johan Henrich Nienkemper takes over from his wife, the widow Plasmeyer, the name Plasmeyer, because both live on the old Kotterfarm of Plasmeyer. He, his wife and his children emigrate later to the United States. Johan Henrich Nienkemper originates, just like his wife, from the village Mastholte over Lippstadt.

It is recommended now for you to read through very precisely, the writings out of the register from Mastholte on this point, because otherwise you will, concerning the names pell-mell from Lutke-Hackenkamp, Nienkamper, Nienkemper, Plasmeyer and Plashues, lose the survey.

Nr. 2

Johan Henrich Nienkemper should properly be named Lutke Hackenkamp. His parents are Herman Lutke-Hackenkamp and Maria Christina Poppelbaum; however, both have from Poppelbaums the by-name Nienkamper or Nienkemper.

The name Poppelbaum is named in the register Mastholte very often in connection with the name Nienkamper. Why this is pell-mell is not clear to state. But one thing is clear: Nienkemper, Nienkamper and Lutke-Hackenkamp are identic. This is very important to know, because Johan Henrich, or just Henrich Plasmeyer, by the birth of his first two children are pointed out as born Lutke-Hackenkamp. Also it must be emphasized, that the names Plasmeyer, Plasmeyer and Plashues are also identic and were mixed up.

The predecessors of Johan Henrich and his wife Elisabeth, born Heckenmeyer, widowed Plasmeyer, you can learn about from the ministry Mastholte over Lippstadt.

Now following the statements about the children from the marriage of Johan Henrich Plasmeyer or Plashues born Lutke-Hackenkamp and his wife Elisabeth, born Heckenmeyer, widow Plasmeyer.

With these children emigrated Henrich Plasmeier, born Lutke-Hackenkamp and his wife Elisabeth born Heckemeier, in August 1857 to North America, except the sixth child, which died after the second month.

The justness of these records out of the registrar, the Catholic ministry St. Margareta in Wadersloh, attested, A. Helmsorig, Minorist. 18. 10. 1960.

Catholic Pastorship--Wadersloh (Beckum)

Following inquiries were made on the 6th of October 1960 in charge of the Catholic pastorship Wadersloh in matters "investigation Plasmeier" in the archives of the Catholic ministry Mastholte over Lippstadt from Adalbert Helmsorig and Josef Reiling.

Abstracts of the christening register Mastholte: annual set 1773, S.88

1. Christened on the 20th of August 1773 Anna Maria Christina, legitimate daughter of Joannes Henricus and Anna Margareta Poppelbaum. Godparents were Anna Maria Christina and Johann Handineck.

Abstracts of the christening register Mastholte: annual set 1778

2. Christened on the 30th day of November 1778 Joannes Hermannus Adamus, legitimate son of Joseph and Maria Lutke-Hackenkamp. Godfather was Adamus Grotehoff and Wulffhorst.

3. Married on the 29th of January 1805 Hermannus Lutke-Hackenkamp and Maria Christina Poppelbaum. Witness: Josephus Grote Hackenkamp and Custos Fahrenhorst.

4. Christened on the 3rd of January 1808 Joannes Henricus Nienkamper, legitimate son of Hermannus and Maria Christina Nienkamper, Kotter by Poppelbaum. Godfather was Henr. Poppelbaum, senior.

5. Christened on the 26th of August 1809 Maria Elisabeth, legitimate daughter of J. Henricus Heckemeyer and Lovisa Nordholt, Kotter by Nordholt. Godmother: Elisabeth

Why the name Lutke-Hackenkamp and Nienkemper was mixed up for the same person, we could not find out. However this arbitrary use was not before the marriage of Herrmannus Lutke-Hackenkamp with Maria Christina Poppelbaum. On the other hand, we found on different other places of different registers, the name Nienkemper always in connection with the names Poppelbaum. Our consideration is, that the name Nienkemper from the wife of Herrmannus Lutke-Hackenkamp, namely Maria Christina Poppelbaum. Their parents apparently had the by-name Nienkemper. Probably, after their marriage they both remained on the farm Poppelbaum, like the addition "Kotter by Poppelbaum" by the christening of Joannes Henricus from the christening register confirmed.

The emigration of the sons of Kotters Kleinehackenkamp call Plasmeyer at Wadersloh who were bound for military duty, concerning to North America.

The statement of today's hand in request about confer the discharge record the family Kotters Kleinhackenkamp gdt. Plasmeyer in the farmstead Benteler district Wadersloh, exist of husband, wife and six children, intend to emigrate to America. Among the children were two sons who were bound for military duty, namely:

1. Anton, born on the 2. of September, 1836
2. Johan Hermann, born on the 2. of February, 1839

The first one belonged to this year's levy and is, because of identified illness of his father's for one year respected, that the second son could learn the woodshoemaker trade from the oldest son, that he could be a support to his parents. That this time the intention to an emigration was planned is very doubting, at least I don't know anything about it. The family is very diligent and saving, but the little land of 14 Morgen (acre) exist of very bad ground, partly heideboden (heathground) and because of the father's long and still continuing illness, the circumstances were very bad and went backward, so that the land now without the hereditary tenure, is charged with more than 600 Rthl. debt. The p. Plasmeyer sold the Kotten (land) and after having paid off his debt, he will have about 600 Rthl. left.

Out of the farmstead Benteler and the nearby community, more families emigrate to America, which had there more relatives who emigrated a long time ago, they found their good advancement, and their emigration came up, because of their fear to become poor through the Bocker-Mastholte drain-matters.

Among those were the p. Plasmeyer too, dissmade from my side were unsuccessful.

Because that the whole family emigrated, there for was the imigration of the of the two oldest sons as well, not because to withdraw themselves from the army and I beg out of this matter obedient, to give them highly suited the necessary certificate.
