When should my child have a hearing test?

- ◆ Family history of hearing loss in childhood
- ◆ Newborn ICU stay greater than 5 days
- ◆ Speech and language concerns
- ◆ Global developmental delay
- ◆ Chronic ear infections or congestion
- ◆ Cleft lip or palate
- ◆ Caregiver concern
- ◆ Cytomegalovirus (CMV) diagnosis
- ◆ Meningitis
- ◆ Blood transfusion due to jaundice
- ◆ ECMO treatment
- ◆ Zika virus

What if my child might not participate?

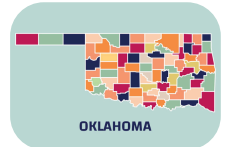

Testing can be done almost anywhere!

- In-home *Caregiver must be present for testing.
- Therapy Clinic (speech, physical, occupational, etc.)
- Childcare Center
- Community Center (library, playground, etc.)
- Pediatrician Clinic
- Midwifery Clinic

On-Site Service Fees

- Newborn Hearing Screening \$75
- Diagnostic Infant Hearing Assessment \$250
- Diagnostic Pediatric Hearing Assessment \$115
- Travel Fee may apply outside of OKC metro
- Reduced fees may be available if serving multiple children/families in one setting
