THE ORGANIZATION FACILITATED 23 STUDENT-ATHLETE-LED GIVEBACK EVENTS, ENGAGING MORE THAN 30 ATHLETIC TEAMS AND COMMUNITY PARTNERS TO SUPPORT YOUTH IN HIGH-POVERTY COMMUNITIES. THESE EVENTS EMPOWERED STUDENT-ATHLETES TO DESIGN AND LEAD SERVICE ACTIVITIES INCLUDING MENTORING, SPORTS CLINICS, COMMUNITY SUPPORT PROJECTS, AND LOCAL NONPROFIT ENGAGEMENT.
