FINAL ORDER APPROVING THE SIXTEENTH ADMINISTRATION BUDGET FOR THE SETTLEMENT

Presently pending before the Court is the Sixteenth Budget for the Settlement Medical Monitoring Program (for the twelve months beginning September 1, 2025 and ending August 31, 2026) (the "Sixteenth Settlement Administration Budget" or the "Budget"), submitted to the Finance Committee on September 22, 2025, with no objections being received.

The Court notes that the Settlement Medical Monitoring Fund Budget is to be funded by the Medical Monitoring Fund Account created by a Court-ordered DuPont contribution on October 31, 2011, and by additional contributions from DuPont, if necessary. According to the Claims Administrator's September 29, 2025 Report to the Court, an additional DuPont funding of the Medical Monitoring Fund Account is required on or before February 1, 2026, in the amount of \$35,000.00, as the Account balance at August 31, 2025 was approximately

\$41,800, and projected Medical Monitoring expenses for the Budget period are approximately \$76,800.

After a careful review of the Sixteenth Settlement Administration Budget, and in consideration of the applicable law, the Court ORDERS that the same is hereby APPROVED and shall be used in the administration of the Settlement, and that DuPont shall issue payment to the Medical Monitoring Fund in the amount of \$35,000.00 by February 1, 2025.

Lastly, pursuant to Rule 54(b) of the West Virginia Rules of Civil Procedure, the Court directs entry of this Order as a Final Order as to the claims and issues above upon an express determination that there is no just reason for delay and upon an express direction for the entry of judgment.
