ORDER APPROVING THE THIRD REVISION OF THE PERRINE MEDICAL MONITORING PLAN TO AMEND THE LIST OF PARTICIPATING PROVIDERS FOR IN-AREA CLAIMANTS

Presently before the Court is the Claims Administrator's September 3, 2014 Report Requesting Court Approval of Further Revision of the List of Participating Providers for In-Area Claimants (the "Third Plan Revision").

In the Report, the Claims Administrator has explained the Third Plan Revision would amend the list of participating in-area providers approved by this Court's January 6, 2012 Order respecting Plan Medical Providers to include a fifth participating provider for in-area claimants, with that provider being Dr. Kelly Nelson. Dr. Nelson formerly worked with MedExpress, and is now opening his own medical practice. Under the proposed Third Plan Revision, Dr. Nelson would be added to the list of Participating Providers, with MedExpress remaining on the list. The Claims Administrator has also related that the Third Plan Revision has been reviewed with the Finance Committee and the Guardian Ad Litem for children, with the Claims Administrator taking into account their suggestions and concerns prior to finalizing the list for submission to the Court with the Report. Dr. Nelson is currently scheduled to examine 260 of the participating claimants, thus, the Claims Administrator believes it is in the best interest of the Plan to include him as a provider.

After a careful review of the August 28, 2014 Third Plan Revision, and a consideration of the applicable law, the Court orders that the Third Plan Revision and its addenda are hereby approved and shall be used in the administration of the Settlement.

Lastly, pursuant to Rule 54(b) of the West Virginia Rules of Civil Procedure, the Court directs entry of this Order as a Final Order as to the claims and issues above upon an express determination that there is no just reason for delay and upon an express direction for the entry of judgment.
