SECOND ORDER MODIFYING FINANCE COMMITTEE COMPOSITION

Presently pending before the Court is a request by DuPont that its representatives on the Finance Committee for the Medical Monitoring Plan be modified. The current DuPont representative was designated by the Court in the June 7, 2012 "Order Modifying Finance Committee Composition."

DuPont's primary representative on the Finance Committee is currently James S. Arnold and David B. Thomas and their proxy William S. "Buddy" Cox, III., Esq. DuPont has nominated two individuals to replace Messrs. Arnold and Thomas on the Finance Committee, and they are Niall A. Paul, Esq. and Clifford F. Kinney, Jr., Esq. of Spilman Thomas & Battle, PLLC.

Class Counsel's representatives would remain as previously Ordered by this Court, except that Perry B. Jones, Esq., who no longer works on this case, would be excluded. Therefore, Virginia Buchanan, Esq., would remain the primary representative, and Farrest Taylor, Esq. and Angela Mason, Esq., would be her proxies.

Accordingly, the Court hereby **ORDERS** that James S. Arnold, David B. Thomas and their proxy, William S. "Buddy" Cox, III, shall be replaced on the Finance Committee by Niall

A. Paul, Esq. and Clifford F. Kinney, Jr., Esq., and Perry B. Jones, Esq., is excused from further service on the Finance Committee, while all other members of the Finance Committee shall remain the same.




