<u>Jeffco Septic Policy</u> – .45-acre property applying for variance. Will need water source. Communicating with Jeffco regarding new septic policy relating to this property.

<u>Boar Head Road</u> – 12.9-acre property borders the District boundary. Owners want to explore water options including tap vs. well for a 2500 sq ft house.
