The Kiowa Tribe Housing Authority invites qualified Construction and Roofing Contractors and/or highly skilled individuals with experience in renovations to submit bids for five (5) privately owned homes located in Hobart, Elgin, Carnegie, and Anadarko, Oklahoma. The proposed project is federally funded under the Native American Housing Assistance and Self-Determination Act of 1996 and will be considered as small purchase procurement. All bid quotes will be assessed and evaluated beginning with bidders ability to follow bid instructions and format as follows.

General Requirements

Bid packet is available to interested bidders and can be picked up at 1701 E. Central Blvd, Anadarko, Oklahoma between the hours of 8:30 a.m. and 4:30 p.m., Monday through Friday, except holidays. A bid packet may be obtained by regular mail by calling Breezy Quoetone at 405.339.8100.

The bidder is to prepare a detailed bid quote that is based on a Scope of Work provided by KTHA for proposed project. All bid quotes are to include a materials list, cost, equipment and related soft cost required to install and complete all work in accordance with Scope of Work. Instructions to Bidders

All bids shall be sent by mail or hand delivered to ensure proper and timely delivery. The KTHA Procurement Office will not be responsible for bid quotes sent by facsimile or email, should there be any missing pages or misprints and information. Bid quotes sent electronically are solely the responsibility of the bidder.

KTHA will take all necessary affirmative steps to ensure that minority firms, woman owned businesses and labor surplus area firms will be used when possible.

Indian Preference: to the greatest extent feasible, the KTHA will give preference in the award of contract(s) to Indian-owned enterprises in accordance with Section 7(b) of the Indian Self Determination and Education Assistance Act (25USC 450e(b)).

All bidders will be contacted with the final results based on compliance with bid requirements. All selected determinations will be final.
