PUPPY PURCHASE AGREEMENT & 2-YEAR HEALTH GUARANTEE

This Puppy Purchase Agreement is entered into between Southview Border Collies ("Breeder") and the undersigned purchaser ("Buyer") for the puppy described below.

3. PURCHASE PRICE

Unless otherwise agreed to in writing, the puppy must be paid for in full before leaving Southview Border Collies.

4. HEALTH AT TIME OF SALE

The Breeder represents that, to the best of the Breeder's knowledge, the puppy is in good health at the time of transfer.

The Buyer is strongly encouraged to have the puppy examined by a licensed veterinarian within 72 hours of taking possession. If a serious health condition present at the time of sale is identified, the Buyer must promptly notify Southview Border Collies and provide written veterinary documentation.

5. TWO-YEAR GENETIC HEALTH GUARANTEE

Southview Border Collies provides a two (2) year health guarantee from the puppy's date of birth against serious hereditary or congenital conditions that significantly affect the puppy's quality of life.

A claim must be supported by diagnosis and appropriate documentation from a licensed veterinarian. Southview Border Collies may request complete veterinary records and/or a second veterinary opinion.

This guarantee does not mean the puppy will never develop an illness or medical condition.

6. CONDITIONS NOT COVERED

The guarantee does not cover conditions resulting from injury, accident, neglect, abuse, improper nutrition, obesity, poisoning, infectious disease contracted after leaving the Breeder, parasites, environmental factors, or failure to provide reasonable veterinary care. Minor or treatable conditions that do not significantly affect quality of life are also excluded.

7. BUYER'S RESPONSIBILITIES

The Buyer agrees to provide appropriate nutrition and clean water, routine veterinary care and vaccinations, parasite prevention, age-appropriate exercise, safe housing, socialization and training, and prompt veterinary treatment when the puppy is sick or injured. Reasonable veterinary records must be maintained during the guarantee period.

8. HEALTH GUARANTEE REMEDY

If the puppy is diagnosed within the guarantee period with a qualifying serious hereditary or congenital condition, the Buyer must provide written veterinary documentation.

Upon confirmation, Southview Border Collies will provide a replacement puppy of comparable value from a future available litter, subject to availability. The Buyer is not required to return the affected dog and may keep and continue caring for it.

Veterinary bills, medications, diagnostic testing, surgery, transportation, and other expenses are not reimbursed unless specifically agreed to in writing.

9. NON-BREEDING / SPAY-NEUTER AGREEMENT

This puppy is sold strictly as a companion/pet on a NON-BREEDING agreement. The \$1,900 CAD purchase price does not include breeding rights.

The Buyer agrees that the dog will not be bred intentionally or accidentally and will not be used for stud service, artificial insemination, semen collection, or any other reproductive purpose.

The Buyer will take reasonable precautions to prevent accidental breeding while the dog remains intact. The dog will be spayed or neutered at an age recommended by the Buyer's licensed veterinarian, considering the dog's health, growth and development. Upon request, the Buyer will provide veterinary confirmation of the procedure.

Any registration provided will be issued or transferred as non-breeding/limited registration where applicable.

The dog may not be bred under any circumstances without prior written authorization from Southview Border Collies. Intentional breeding without written authorization constitutes a material breach of this agreement.

10. CARE AND WELFARE

The Buyer agrees that the dog will be treated humanely and provided appropriate food, shelter, veterinary care, exercise, training and companionship. The dog will not knowingly be used for dog fighting, puppy-mill breeding or unlawful activity.

11. RETURN TO BREEDER / NO SHELTER SURRENDER

If at any time during the dog's life the Buyer is unable or unwilling to keep the dog, the Buyer agrees to contact Southview Border Collies before surrendering, selling, giving away or otherwise transferring the dog.

Southview Border Collies must be given the opportunity to assist with return or appropriate rehoming. The dog is not to be surrendered to an animal shelter, rescue organization, pound or similar facility without first contacting Southview Border Collies, except where required by law or in an emergency affecting the dog's immediate welfare.

Returning the dog does not automatically entitle the Buyer to a refund of the original purchase price.

12. TRANSFER OF OWNERSHIP

Ownership transfers when the purchase price has been paid in full and the puppy has been physically transferred to the Buyer. The Buyer assumes responsibility for routine care and expenses from that date.

13. ENTIRE AGREEMENT

This document represents the entire agreement regarding the purchase of this puppy, the two-year health guarantee and the non-breeding requirement. Changes must be made in writing and agreed to by both parties.

BUYER ACKNOWLEDGEMENT

I have read and understand this Puppy Purchase Agreement, 2-Year Health Guarantee and Non-Breeding/Spay-Neuter Agreement. I understand that I am purchasing this puppy for \$1,900 CAD as a companion animal without breeding rights and agree to its terms.
