We, the undersigned, qualified electors and registered voters residing within the City of Chicago, Cook County, Illinois, who have affixed our signature in our own proper person to this Petition, do hereby petition, pursuant to Sections 6 (f) and 11 of Article VII of the Illinois Constitution and Article 28 of the Illinois Election Code, that the following question of public policy be placed on the ballot and submitted to the voters of the City of Chicago for their approval or disapproval, by referendum, at the next regular election to be held at least 92 days after the filing of this Petition and if approved, the question shall take effect immediately upon referendum approval.
