FORM A-45/E (CLASS E)  
ALLOWS AN THIRD PARTY APLICANT TO ENDORSE UP TO THREE LOCAL BUSINESSES (NO WEB BASED  
BUSINESS YET HOWEVER COMMING SOON) AND PARTICIPATE IN SUPPORTING APROVED BUSINESSES  
CHARITABLY [ NON-TANGIBLDE CHARITY ONLY ]. APLICATION MUST BE APROVED AND ACCEPTED  
BY A CORPORATE OFFICER AND WILL BE UNDER THE SUPERVISION OF A EXECUTIVE ASSOCIATE.

FORM A-45/F (CLASS F)  
ALOWS AN APLICANT THAT IS CURRENTLY EMPLOYED TO RECOMEND THEIR BUSINESS OF  
EMPLOYMENT FOR ENDORSMENT AND ALLOWS THE APPLICANT TO PRACTICE (WITHIN THE CONFINES  
OF THEIR CURRENT EMPLOYMENT STANDARDS). APLICATION MUST BE APROVED AND ACCEPTED AND  
SUPERVISED BY A CORPORATE OFFICER.

FORM A-45 'PRIOR TO SEP 8TH'  
ALL PREVIOUS A45 FORMS PRIOR TO SEP 8TH 2023 WERE DISCONTINUED ON SEP 9TH 2023 AND  
ARE NO LONGER VALID.
