RESPONSIBILITIES AND REQUIREMENTS OF BOOKING PARTY:

1. BOOKING PARTY SHALL PAY A **ONE HUNDRED (\$100) DEPOSIT** AT THE TIME OF BOOKING OR CONTRACT SIGNING – NO DEPOSIT – NO DANCE!
2. BOOKING PARTY SHALL PAY IN CASH, CHECK OR WITH A MONEY ORDER. ALL MONEY ORDERS SHOULD BE MADE OUT TO HEART BEAT, ANY RETURNED CHECKS WILL BE CHARGED \$45.00.
3. BOOKING PARTY SHALL PROVIDE A 6'X8' SETUP SPACE, ADEQUATE POWER SOURCES. FOR OUTDOOR EVENTS SHELTER FOR EQUIPMENT. IF A FIVE FOOT TABLE IS AVAILABLE, PLEASE SUPPLY ONE.
4. BOOKING PARTY IS RESPONSIBLE FOR DAMAGE TO EQUIPMENT OF HEART BEAT BECAUSE OF NEGLIGENCE BY SOMEONE AT THEIR EVENT.
