

At about 1:30 am, a resident who knew I wanted to observe the Street Sweeping process in our District 4, let me know the Sweeper was on her street. I drove over to talk with the driver. He gave me a full explanation of the process.

No chemicals are used, but water is sprayed on the street as needed to keep the dust down, a brush scrubs the street next to the gutters, and a vacuum sucks the debris into a storage box on the back of the vehicle. When the box is full, it is taken to a designated dump site. It takes about 4-5 hours over 4-5 days to do all the roads in District 4.


