New MCSO Commander At CR42 Office

A new commander has been promoted to take over at the Marion County Sheriff's Office annex in The Villages.

Sqt. Benjamin Adams is the new commander for MCSO at Mulberry Grove.

The office oversees and serves more than just the Marion County section of The Villages. The District also includes Spruce Creek, Stonecrest, Summerfield, and other area communities.

Sqt. Adams has been with the Sheriff's office for 17 years. In 2015, he was named the American Legion's Southern Region Law Enforcement Officer of the Year.

Prior to joining law enforcement, he served in the U.S. Marine Corps, including an 18-month deployment in Iraq.

Sqt. Adams plans to take a more active role to interact with the community. On March 13th, he made a point of attending District 4's Town Hall meeting and had an opportunity to introduce himself to the residents in attendance.

AAC MARCH 6th Regular Meeting Highlights:

1) Audience Comments:

Extensive resident comments were received expressing frustration about not being allowed to play cards, games, and gamble at the recreation centers. Residents expressed support for how the games help with social and mental skills. District Legal Counsel advised that under Florida State law, gambling is illegal at the District's recreation centers. Staff advised that affected groups can re-apply for room reservations, at which time a signed Room Reservation Agreement which states "NO GAMBLING IS ALLOWED" would be required.



2) Consent Agenda:

A motion to approve the Consent Agenda is a motion to approve all recommended actions. All matters on the Consent Agenda are considered routine and no discussion is required unless desired by an AAC Member, or a Member of the Public.
