- Market hours are from 9AM -12 noon, set up begins at 7AM.
- You are required to bring your own table and/or tent.
- There is a one-time \$10 market application fee, then a reoccurring "booth fee" is \$8 per market.

**For the Winter Market, please be aware of the following:**

- Our Winter location is the Lower Level of the Johnson County Welcome Center.
- Market hours are from 9AM -12 noon, set up begins at 8AM.
- You are not required to bring tables as they are already provided.
- There is a one-time \$10 market application fee, then a reoccurring "booth fee" is \$10 per market.

The Market Manager will be asking each vendor to RSVP via email each week as to whether they plan to be at the market the following Saturday. If you are interested in attending that week's market, please respond to the email with the following information:

- Your name
- Your business's name
- What items you plan on bringing to sell
- How many tables (indoor season) or booth spaces (outdoor season) you need

If you have said that you will be there and that changes, please call or text the Market Manager so that there are no empty spaces at the market and/or we can open up that space to another vendor if necessary.
