## 2020 Market Season

### **For the Summer Market, please be aware of the following:**

- Our Summer location is Ralph Stout Park in Mountain City, TN.
- Market hours are from 9am - Noon, set up begins at 7am.
- We ask you to bring your own table and/or tent.
- We do have a limited amount of tents and tables for rent on a first-come basis
- "Booth fee" of \$8 per market day.

### **For the Winter Market, please be aware of the following:**

- Our Winter location is the Lower Level of the Johnson County Welcome Center.
- Market hours are from 9am - Noon, set up begins at 8am.
- You are not required to bring tables as they are already provided.
- You are required to break down tables at the end market.
- The Winter Market does not accept any tokens during the winter season.
- "Booth fee" is \$10 per market day.

JCFM will be asking each vendor to RSVP via email each week as to whether they plan to be at the market the following Saturday. If you are interested in attending that week's market, please respond to the email with the following information:

- Your name
- Your business's name
- What items you plan on bringing to sell
- How many tables (indoor season) or booth spaces (outdoor season) you need

If you have said that you will be there and that changes, please contact the JCFM so that there are no empty spaces at the market and/or we can open up that space to another vendor if necessary.

Both the signed application and \$10 application fee are due before the vendor is permitted admittance to participate in the Johnson County Farmers Market.
