I agree to serve as an independent contractor for the Northeast Officials Association (NEOA) with respect to any officiating assignment I accept. I understand and agree that I am not an employee of the NEOA, the NCHSAA, or the Regional Supervisor of Officials. I agree to assume responsibility for my own actions and conduct while performing any assignment and to hold harmless and indemnify the Regional Supervisor of Officials and the Northeast Officials Association from claims, liabilities, damages, or expenses arising from my actions or omissions in connection with an assignment, except to the extent caused by the negligence or willful misconduct of the party seeking protection. I hereby certify that I am physically and mentally capable of performing the duties and responsibilities associated with officiating basketball games to which I may be assigned. I agree to immediately notify the NEOA Regional Supervisor if a condition arises that prevents me from safely and properly performing my officiating responsibilities. I understand and agree that this registration and contract is valid for one (1) basketball season and will terminate upon completion of the NCHSAA Basketball State Championships for that season, unless otherwise terminated in accordance with applicable NEOA policies.

I understand that this registration and contract does not guarantee or obligate the NEOA or the Regional Supervisor to provide me with any specific number, level, location, or type of game assignments. Assignments are based upon the needs of the association, availability, qualifications, performance, and other factors determined by the Regional Supervisor.

I understand that any assignment issued to me may be canceled or changed by the Regional Supervisor when, in the Regional Supervisor's judgment, such action is in the best interest of the official, the schools involved, or the NEOA. Once an assignment has been published, any assignment that I return or decline is subject to a \$25.00 cancellation fee per returned assignment, unless the Regional Supervisor authorizes an exception. Any applicable cancellation fee shall be payable within three (3) days of the date the assignment is returned or declined. I understand and agree that all changes to game assignments must be made through the NEOA Regional Supervisor. Officials are not authorized to independently exchange, transfer, alter, or otherwise change game assignments without prior approval from the Regional Supervisor. By signing this agreement, I certify that I have not been convicted of a felony. I further agree that, if I am charged with a felony during the basketball season, I will immediately notify the NEOA Regional Supervisor and provide any information reasonably requested concerning the charge.

I understand that my continued eligibility to officiate is subject to compliance with applicable NEOA, NCHSAA, and NFHS rules, policies, requirements, and procedures.
