Restrictions

Cone even with east edge of 54th St parking lot straight north to path 56th St- Runners stay on north side of blvd from Fishermans Dr To 6th Ave Cones down center of road to separate two way runner traffic on:

7th Ave from 79th St to 85th St 6th Ave from 54th St to 50th St 50th St from 7th Ave to Kennedy Dr Kennedy Dr from Simmons Island Dr to bike path just east of 7th Ave

Wisconsin Marathon Mile Marker Descriptions

Start-Fishermans Dr, on edge of parking lines. Even with light post on east side of parking lot and 10" north of 13th parking line from south end of parking lot

Mile 1- West curb 7th Ave, even with sewer drain in center of road across from P34 door of parking garage

Mile 2- West edge 7th Ave,15'3" south of 1st utility pole on west side south of 77th

Mile 3- West edge 7th Ave, 66' south of 4th utility pole on east side, south of 85th

Mile 4- East edge 3rd Ave, even with 8735 mailbox

Mile 5- East curb 7th Ave, even with south edge of 7954 driveway

Mile 6- West curb of 1st Ave, even with north edge of 7114 driveway

Mile 7- East edge of path, even with Dr. Vince and Mary Rizzo plaque by tree on east side of path and just south of 2nd bench on west side of path north of entrance from 3rd Ave

Mile 8-West Edge of path closest to water, 2'6" north of 1st light pole on west side south of end of path

Mile 9- South curb 50th St, 4'4" east of 1st utility pole on south side at east end of intersection of Kennedy Dr

Mile 10- East curb of Kennedy Dr, 16'1" south of curb on corner of entrance to parking lot Turnaround- center of bike path,17'4" northwest of 1st light pole on east side south of Kennedy Dr

Mile 11- West edge Kennedy Dr, 23'8" north of 1st light pole on west side south of bathrooms

Mile 12- West edge of Kennedy Dr, 6'2" south of 2nd utility pole on west side north of 50th St

Mile 13-South edge of path, 4'13" west of sidewalk to Harbor path and towards 54th St

Mile 14- West curb 7th Ave, 7' south of 2nd light pole on west side south of 61st St

Mile 15-West curb 7th Ave, middle driveway break in northmost entrance to Morelli's

Mile 16- West edge 7th Ave, even with sewer drain at south end of intersection of 85th St

Mile 17- East edge 3rd Ave, at north edge of of south entrance to 8754 driveway

Mile 18- East edge 7th Ave, 69'3" north of speed limit 25/no parking sign on east side south of 80th St

Mile 19-West curb 1st Ave in middle of 7310 driveway

Mile 20- East curb 3rd Ave, 6'5" north of sidewalk to 6221

Mile 21- West edge of path, 15'10" south of 1st light pole on west side south of the north edge of the marina building

Mile 22- South curb 50th St, 16'9" east of bridge expansion joint on west edge of bridge

Mile 23-East curb Kennedy Dr, 33'4" north of no parking sign on east side in middle of 45th St intersection

Turnaround- center of bike path,17'4" northwest of 1st light pole on east side south of Kennedy Dr

Mile 24-West edge bike path, 6'6" south of 1st tree on west side of path south of Kennedy Dr Mile 25- West edge Kennedy Dr, 10'4" north of large tree closest to road and south of playground

Mile 26- South edge of path, even with 1st streetcar pole on south side of path just south of Bear sculpture

Finish-Same as Start
