#### STEP 3: Think Through the Big Questions

- □ Do you want to keep income or property separate?
- □ Will debt stay with the person who brought it in?
- □ Should either of you waive spousal support?
- □ How will you handle shared purchases (home, car)?
- □ What happens if one of you pauses your career for kids?

□ Emphasize partnership and planning, not mistrust



#### **STEP 6: The Legal Process**

□ One of you hires a lawyer to draft the prenup

- □ The other hires a lawyer to review it (required!)
- □ Negotiate the agreement by going back and forth with the attorneys' involvement
- □ Finalize and sign well in advance of your wedding
- □ Keep a signed copy in your records, and revisit if your lives change
