 2. Vehicles should be parked around the Clubhouse area and <u>not</u> on otl 	her lot owner's private property.	
3. You are responsible for the behavior and actions of your guests.		
\square 4. All children must be supervised by an adult at all times. This includes	swimming, fishing, golf cart rides, wa	ilks in the
Valley, playground and use of the paddle boat.		
5. No fishing from the paddle boat or the swimming raft.		
6. No smoking in the Clubhouse. Smoking is allowed in the outside area	a, but please clean up after yourself ar	nd your guests.
7. No dogs are allowed in the Clubhouse.		
8. No sleeping overnight in the Clubhouse.		
$\ \square$ 9. The Clubhouse sanitation system is limited. Groups larger than 25 pe	ersons should plan on using the memb	per's RV facilities to
supplement the sanitation facilities, particularly if the Clubhouse is to be used for more than three (3) hours.		
10. You must furnish your own paper plates, cups, utensils, napkins and	d food items.	
\square 11. The water heater should be turned <u>off</u> at the electrical box located	next to the water heater before leavi	ng. The circuit
breaker is marked.		
12. The Clubhouse must be thoroughly cleaned, including bathrooms, at the end of your day. This includes the outside picnic		
areas, as well. Once the Clubhouse is inspected and approved, your \$100.00 deposit will be refunded to you.		
13. If, upon the Clubhouse inspection, any property damage is found, your deposit will not be refunded and there will be an		
additional charge billed to the Lot Owner for said property damage	es and repairs.	
\square 14. All lights, fans and appliances should be turned off. Coffee pots should be unplugged from the wall.		
15. Remove all garbage, including bathrooms, and dispose of it in the garbage receptacle located at the entrance of the Valley.		
16. The Clubhouse should be <u>locked up</u> making sure to include the sliding glass doors facing the lake.		
17. Reservations of the Clubhouse are <u>not</u> accepted over major holidays.
