Important Notice: ACCA Registration and subscription fees

If you register on or before the late entry June deadline for each year, you will be invoiced the annual subscription fee as you're eligible to sit exams in the June, September and December sessions. Check important dates. After that your annual subscription fee is due and payable on or before 1 January each year if you wish to remain an active student. We send you an invoice every November. You need to pay this even if you don't plan to take any exams that year.

And if you forget to pay, you may be removed from the register of students and have to pay a re-registration fee, as well as any outstanding fees, to enable you to continue with your studies. Remember, you have to pay this whether or not you're planning to take exams that year.
