Mere’s Fest agrees to provide onsite space to conduct Vendor’s business in Mere’s Fest Event at Mere’s Reserve on The Colorado. Vendor use of Mere’s Fest space is limited to the space provided by Mere’s Fest and is identified prior to Event. In general, Vendor is guaranteed a space.

_____ Accepts the opportunity to participate as a Vendor in Mere’s Fest commencing on Saturday July 2nd, 2022 at 12 P.M. CST and ending on Sunday July 3rd at 11:59 P.M. CST. Vendor hereby agrees with the following listed conditions and limitations.

VENDOR AGREEMENT

All vendors participating in Mere’s Fest understand the following rules and by participating as a vendor in Mere’s Fest, thereby are agreeing to adhere to the following:

- All vendors agree to be at the location, parked in the vendor parking area by no later than 9 AM on each day/ or singular day of the festival.
- All vendors understand Mere’s Fest & its staff are not responsible for providing electrical connections, they must bring their own generator/ lights for their area.

- All vendors agree to provide their own tent for their allocated space and accept the responsibility of ensuring that their tent is properly secured.
- All non-food vendors understand they are only receiving two passes to Mere's Fest that are intended for themselves and a helper. They are not to be traded/ switched out during the event. Anyone who is in a vendor tent must have a valid entry ticket or one of the two vendor wristbands.
- All food vendors understand they are only receiving four passes to Mere's Fest that are intended for themselves and their staff. They are not to be traded/ switched out during the event. Anyone who is in a vendor area must have a valid entry ticket or one of the four vendor wristbands.
- The Vendor, is solely responsible for obtaining a County of Bastrop Temporary Food Permit from the County of Bastrop at https://www.co.bastrop.tx.us/page/ds.retail_food .
- All vendors agree to maintain an orderly station and are subject to any necessary clean-up fees if there is additional cleaning needed.
- All food vendors are responsible for proper food disposal and are not to leave any food in open air at Mere's fest overnight.
- Vendor agrees to comply with all applicable City, County, State, and Federal laws and shall conduct no illegal act on the premises. This is a drug free and non-smoking facility at all times, and there are no exceptions.
- Vendor shall not sell alcohol on premises at any time. Renter may not serve alcohol to minors on the premises at any time.
- Mere's Fest, reserves the right, in its exclusive discretion, to expel anyone who, in its judgment, is intoxicated or under the influence of alcohol or drugs, or who shall, in

any manner, do or participate in any act jeopardizing the rights, use permit, or insurability of Mere's Fest, or the safety of its staff, guests, or event content.

LIABILITY. Renter agrees to indemnify, defend and hold Mere's Fest, its landlord, building owners, officers, employees, and agents harmless of and from any liabilities, costs, penalties, or expenses arising out of and/or resulting from the rental and use of the premises, including but not limited to, the personal guarantee of provision, service, and dispensing of payment by renter, its employees, and agents of alcoholic beverages at Mere's Fest. In the event Mere's Fest, its landlord, building owners, officers, employees and/or agents, are required to file any action in court in order to enforce any provisions of this agreement, the renter agrees to pay Mere's Fest its officers, landlord, building owners, employees and/or agents, all reasonable attorney fees, court fees, and costs of suit incurred by Mere's Fest including all collection expenses and interest due.
