Tuition Rates and Fees for Penny Lane Childcare

****Minimum enrollment is 3 FULL days or 4 HALF Days per week****

Infants: 6 weeks - 12 months (walking consistently)

Registration Fee: A \$50.00 non-refundable registration fee is charged to each family upon enrollment.

Late Pickup Fee: There is a late fee charge of \$1.00/minute for children not picked up by closing time. After five late pickups, the charge will be \$5.00 per minute.

Late Payment Fees: Weekly tuition is billed every Monday and due by Wednesday of the current week. Monthly tuition is billed on the 1st of each month and due by the 5th of the month. Late fees will be assessed to accounts that are delinquent; a \$10.00 charge weekly or \$40.00 monthly charge. Enrollment may be terminated if fees are more than two weeks delinquent.

Illness: If your child is absent for more than 2 consecutive weeks, WITH A DOCTOR'S STATEMENT, we will waive the fees.

Financial Assistance: Local resources available for families to help with childcare costs. CCDF (Child Care Development Fund) The Child Care Development Fund (CCDF) is a federal program that assists low-income families with childcare costs so they can work or continue their education. Check with the director to see if your family meets the eligible requirements.

Withdraw: Parents may withdraw a child from the program at any time. A 2-weeks' notice is required. If you fail to give a 2-week notice, your account will be charged for the 2 weeks. Withdraw and subsequent re-enrollment will entail a new registration fee plus any un-paid balance.
