Registration Fee: A \$50.00 non-refundable registration fee is charged to each child upon enrollment.

Late Pickup Fee: There is a late fee charge of \$1.00/minute for children not picked up by closing time. After five late pickups, the charge will be \$5.00 per minute. **There will be a 5-minute grace period for late pick-up charges.**

Late Payment Fees: Weekly tuition is billed every Monday and due by Wednesday of the current week. Monthly tuition is billed on the 1st (which may fall within a billing week) of each month and due by the 5th of the month. Late fees will be assessed to accounts that are delinquent; a \$10.00 charge weekly or \$40.00 monthly charge. Enrollment may be terminated if fees are more than two weeks delinquent.

Illness: If your child is absent for more than 2 consecutive weeks, **with a doctor's statement**, we will waive the fees.

Financial Assistance: Local resources available for families to help with childcare costs. CCDF (Child Care Development Fund), On My Way PreK, and MCCSC. Check our website pennylanechildcare.net for more information.

Withdrawal: Parents may withdraw a child from the program at any time. A 2-weeks' notice is required. If you fail to give a 2-week notice, your account will be charged for the 2 weeks. Withdraw and subsequent re-enrollment will entail a new registration fee plus any un-paid balance.
