CALL TO ORDER: The November meeting of the Mesquite Club Executive Board was called to order by President Cherie Williams at 10:00 a.m.

SECOND VICE PRESIDENT: Elsa

Torgerson reported that new member orien-

TREASURER: Lynda Schultz handed out the October financial data for the Mesquite Club. It was filed as submitted.

FINANCIAL SECRETARY: Nancy Zangl said that total income for October was \$11,954.50. Her report was filed as submitted.

Elected Chair Reports

Ways and Means: Joan Dimmitt reported that total income generated by Ways and Means to date is \$1,572.75. The Fiesta luncheon went well and we happily contributed \$450 to the student mariachi band. She has 19 bakers lined up for the December 1, bake sale.

Community Service: Corinne Mewhirter was congratulated on the successful Soup-er event. All agreed that the five soups, served to the attendees, were delicious.


EVENING CHAIR REPRESENTATIVE: Jane Reid reported that the evening group held a successful Halloween Bunco and raised over \$1,000. Evening held its first social luncheon on October 21 and recruited one new prospective member. They are having their Holiday Craft Auction on November 17 and having their Holiday Party on December 5, at Carrabba's Italian Grill. **Building:** Cathi Poer reported that we had work done on the lights in the parking lot. She said we have several rentals coming up and our new dishwasher is working out well. There have been problems with keys when "dogging" the front door and she has had several new keys made. She clarified John's duties to the Board when questioned about his helping out at functions and said he will continue to work as a custodian, not as a server, unless he agrees to help and is paid by the member. Cathi Poer made a motion to purchase a new pre-lit Christmas Tree at a cost, not to exceed \$335. The motion carried. She is searching for a new tree.

REST IN PEACE MESQUITE SISTERS

SARA SOUTHARD



Sara Alice Renshaw Southard passed away peacefully October 1, 2017. She was born November 8, 1931, to George Kavanaugh

Renshaw and Bertha Reese Renshaw, in Tupelo, Mississippi. She attended Blue Mountain College and Mississippi College and graduated from the latter with a Bachelor of Science degree in mathematics. She later taught high school mathematics before beginning a career in civil service at Elgin Air Force Base in Florida.

Her first position was a mathematician and a computer programmer, writing programs for ballistic trajectories and aircraft flight maneuvers. Sara was later selected by the U.S. Air Force for a graduate study program where she earned her Masters of Science degree in Mathematics from the University of Arizona. In 1966, she transferred to Nellis Air Force Base in Las Vegas as a Mathematician and an Operations Research Analyst for the Tactical Fighter Weapons Center. During these years, she experienced flying Mach 2 in the F-4 aircraft and evaluated new combat weapons systems while on a tour to Vietnam and Thailand. After 25 years of civil service, Sara qualified for early retirement as the senior ranking civilian woman in the Tactical Air Command with a rating of GS-14. Sara married the love of her life, William Wilson Southard, a successful businessman and a civic leader, in 1978, in Las Vegas. After retirement, she joined the Las Vegas Mesquite Club, where she served as President in 1986-87. It was while in the Mesquite Club that she forged many dear friendships. She also was a past president in the Las Vegas P.E.O. Sisterhood Chapter G, Salvation Army Women's Auxiliary and a Charter member of Canyon Ridge Christian Church. She lived her last remaining years close to her family in northern Nevada. Sara is survived by her two stepsons, Scott Southard (Mendy) of Gardnerville, and James Southard (Kelly) of Reno; two grandchildren, Amanda and Ryan; and one greatgrandchild, Kyson.

HAMILTON M.

Hamilton will be at the Smith Center from May 29, thru June 24, 2018

An American Musical is a sung and rapped through musical about the life of American Founding Father Alexander Hamilton, with music, lyrics and book by Lin-Manuel Miranda, inspired by the 2004 biography Alexander Hamilton by historian Ron Chernow. Notably incorporating hip-hop, rhythm and blues, pop music, soul music, traditional-style show tunes and color-conscious casting of non-white actors as the Founding Fathers and other historical figures, the musical achieved both critical acclaim and box office success.

The musical made its Off-Broadway debut at The Public Theater in February 2015, where its engagement was sold out. The show transferred to Broadway in August 2015 at the Richard Rodgers Theatre. On Broadway, it received enthusiastic critical reception and unprecedented advance box office sales. In 2016, Hamilton received record-setting 16 Tony nominations, winning 11, including Best Musical, and was also the recipient of the 2016 Grammy Award for Best Musical Theater Album and the 2016 Pulitzer Prize for Drama. The prior off-Broadway production of Hamilton won the 2015 Drama Desk Award for Outstanding Musical as well as seven other Drama Desk Awards out of 14 total nominated categories.

Of course, these forms must be adapted by the attorney who makes use of them to the requirements of the particular instrument that they are drafting. They must be aware of the interrelationships between such bequests and the other provisions of your will.
