Since Anita retired from a Fortune 500 Company and Information Technology where she had started with IBM Corporation, she has devoted her time to promoting the arts. In 2004, Anita joined

GFWC Dublin/San Ramon Women's Club in California and quickly volunteered to chair the two, city-wide student art contest for all K-12 students. Anita was responsible for the initiative to hang and display hundreds of pieces of that art in an art gallery in each city every March for Student Art Month. She revitalized the spring student art reception where the winning students received awards in the form of cash, ribbons, and certificates from various city and federal dignitaries. Anita also served two- year terms as club Treasurer, First V.P and Director of New Business, and she was active on the Board. She established the 'Creative Corner' in her local club's newsletter where she wrote articles about the arts.

Anita also became the chair of the Mt. Diablo District Arts for 2 years and then provided arts leadership to over 13,000 CFWC volunteers in the State of California as State Arts Chairman for a total of 4 years. As State Arts Chairman, she developed and produced state convention workshops, wrote articles for the California Clubwoman, inventoried and produced at the annual state convention, not only the Clubwoman Arts & Crafts exhibit, but also the Student Art & Photography exhibit. This involved inventorying and displaying hundreds of all the first place district winners of the art/photography contests. Anita utilized independent art, crafts and photography judges for the judging. Of course the awards consisted of Gift cards, ribbons and certificates. Every piece of art, crafts, and photography was returned along with a certificate of participation. Anita also chaired the CFWC music competition and awarded music scholarships annually.

In addition to her GFWC contributions to promoting the arts, Anita served eight years as the City of Dublin Heritage & Cultural Arts Commissioner and four years as an Alameda County Arts Commissioner. She has left her footprints on some of the public art in the San Francisco Bay Area. Anita has received U.S. Congressional Certificates of Recognition for her Arts and Community Service Volunteerism from two different U.S. Congressmen. She has also judged art for their Congressional Art Contests. Anita also weaves silk tapestries and has recently taken watercolor painting lessons. Please welcome Anita to the Club.

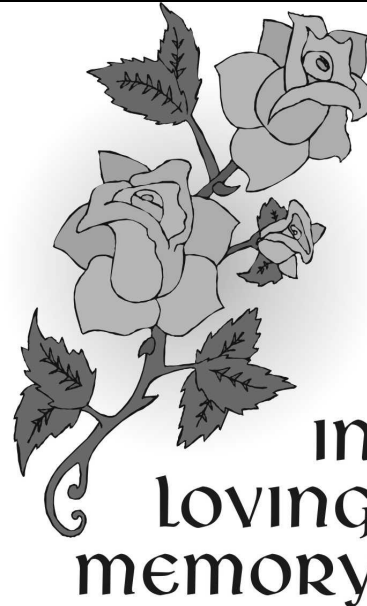
