

The event is SOLD OUT!!


Many thanks to Toni Babbish who stepped right up to Chair our Scholarship Committee for the rest of the 2023-24 Club year.

Holiday Sticky Buns

Recipe courtesy of Ina Garten

Level: Easy Total: 55 min Prep: 20 min Inactive: 5 min Cook: 30 min Yield: 12 sticky buns

Ingredients:

12 tablespoons (1 1/2 sticks) unsalted butter at room temperature

1/3 cup light brown sugar, lightly packed

1/2 cup pecans, chopped in very large pieces 1 package (17.3 ounces/ 2 sheets) frozen puff pastry, defrosted

For the filling:

2 tablespoon unsalted butter, melted and cooled 2/3 cup light brown sugar, lightly packed

3 teaspoons ground cinnamon 1/2 cup dried cranberries

1/2 cup white raisins

Directions:

1 Preheat the oven to 400 degrees f. Place a 12-cup standard muffin tin on a sheet pan lined with Parchment paper.

2 In the bowl of an electric mixer fitted with the paddle attachment, combine 12 tablespoons of butter and 1/3 cup brown sugar. Place 1 rounded tablespoon of the mixture in each of the 12 muffin cups. Distribute the pecans evenly among the 12 muffin cups on top of the butter and sugar mixture.

3 Lightly flour a wooden board or stone surface. Unfold one sheet of puff pastry with the folds going left to right. Brush the whole sheet with 1 tablespoon of the melted butter. Leaving a 1-inch border on the puff pastry, sprinkle each sheet with 1/3 cup of brown sugar, 1 1/2 teaspoons of cinnamon, 1/4 cup of the cranberries and 1/4 cup of the raisins. Starting with the end nearest you, roll the pastry up snugly like a jelly roll around the filling, finishing the roll with the seam-side down. Trim the ends of the roll about 1/2 inch and discard. Slice the roll in six equal pieces, about 1 1/2 inches each. Place each piece, spiral side up, in six of the muffin cups. Repeat with the second sheet of puff pastry to make 12 sticky buns.

4 Bake for 30 minutes, until the sticky buns are golden to dark brown on top and firm to the touch. Allow to cool for 5 minutes only, invert the buns onto the parchment paper. (ease the filling and pecans out onto the buns with a spoon) and cool completely.

White Chocolate Peppermint Fudge

Level: Easy Total: 1 hour 15 min (includes chilling time) Active: 15 min Yield: about 115 pieces

Ingredients:

4 cups marshmallows (about 36)

2 cups sugar

1 cup heavy cream

4 tablespoons unsalted butter Pinch kosher salt

3 cups white chocolate chips (18 ounces) 1 teaspoon pure vanilla extract

10 peppermint candies, crushed

Directions:

Line a 9-by-13-inch pan with foil. Bring the marshmallows, sugar, cream, butter and salt to a simmer in a medium saucepan over medium heat, stirring constantly. Continue to stir until the marshmallows melt and all the sugar dissolves. Remove the saucepan from the heat, add the white chocolate chips and vanilla, and stir until the chips are completely melted.

Pour the mixture into the prepared pan, and scatter the crushed candies over the top.

Let cool to room temperature, then wrap and refrigerate until chilled and firm, about 2 hours. Cut into 1-inch squares.



MESQUITE CLUB EXECUTIVE BOARD MEETING

November 7, 2023

Call to order: President Frankie Segel called the meeting to order at 10:01 a.m.

First Vice President: Sandra Ackerman expressed her and her family's thanks to everyone in the Club for their kind thoughts and words upon the death of her sister, long time Member, Joan Powell. She will advise us when they will be holding a Memorial Service. She also announced that, in lieu of flowers, Joan requested donations to the Mesquite Club. Sandra went on to discuss the hospitality duties and to inform the Board and future hostesses that they need only submit a floorplan to John King, caretaker, and that he will take care of the rest regarding beverage set up. It was also noted that, since John is usually at the Clubhouse during the day, the homeless population has dwindled.

Second Vice President: Mickey Pajor announced that we have four new members: Carol Titus (D), Marie Titus (E), Regena Cob (D) and Rita Dorn (E). Mickey also let us know that, in the future, all new members will have a star on their badges to easily identify them as new members and to be sure we welcome them to the Club. Ms. Pajor also inquired as to the status of the Mentor Program. Was it still something we were doing? If so, she needs volunteers to be Mentors. After discussion, it was the consensus that we don't need a formal program as we are all mentors to our new members. Regarding new members, it was suggested that, rather than having a formal New Member Tea in January, we invite new members to attend our February Board Meeting. At this time, they can see what the Board does, and each Officer and Chair will give a short synopsis of the duties of their office. Consensus was to do this and that all members will contribute to the refreshments.

Nomination Chair: Brenda Dupont announced that the Nominating Committee had met via phone and unanimously agreed to the following recommendation: "By direction of the Nominating Committee, I move that Dianne Steele be elected to the position of President-Elect of Mesquite Club for the 2023-2024 Year."

Treasurer's Report: Corrine Mewhirter reported that the Budget Committee met and updated the 2023-2024 budget. At which point she brought forth the following motion: "I recommend we pass the Budget for 2023". Motion seconded and adopted (motion attached). Treasurer Mewhirter announced that the Evening Community Service Day Committee has raised \$2,188 for Project 150. With a budget of \$8,000 they need to raise an additional \$5,812. Evening Community Services has raised \$2,2930.99 to date. They will need to raise an additional \$15,069.01 to meet their budget of \$18,000. Ways & Means Day has raised \$5,521 to date and needs an additional \$4,479 to meet their \$10,000 budget. Evening Ways & Means need an additional \$1,725 to meet their budget of \$4,000. Treasurer Mewhirter reported that there was an increase in our insurance cost of \$243.13. She is attempting to contact the agent to clarify.

Financial Secretary: Chairman Nancy Zangl distributed the October 2023 Financial report which shows a total income of \$8,620.96 which includes Community Service and Ways & Means as well as \$3,706.00 raised to date for the Evening Holiday Craft Auction.

Building Chair: Recording Secretary, Peggy Bruhns, read the report submitted by Chair Williams-Dewitt. The report included the following recommendation: "Recommendation to the Board of Directors from the Building Committee is that the Mesquite Club contract with John King as caretaker at a salary of \$950 per month for a period of 12 months (11/1/2023 – 10/31/2014), with the opportunity for renewal at that time." Recommendation adopted (attached). Chairman Williams-DeWitt reported that the door company came to inspect the door and it was recommended that we replace the doors rather than try to repair again for an estimate of \$10,000. After discussion, it was decided that we investigate alternative fixes. The Open Market was held on Saturday, October 28, 2023. There were 16 vendors. Income as \$1,000 less \$50 per vendor for Special Event permits for a total income of \$800. As this was our first attempt at this type of event, there were some logistical issues but, after discussions with vendors, we know how to do it better next time.

Community Services: Chairman Chris White reported that the Fall Harvest event for Project 150 was a success. Over \$200 in goods were donated and over \$2,000 was raised. We will continue to collect items including small travel sizes that they use in hygiene bags distributed to clients. The next event will be the April Tea for which she is looking for sponsors to provide the food for the event in hopes of elevating the event for which we are charging \$50.

Evening Representative: Delores Martinez was present and reported that the October Ways & Means Halloween Bunco as a success with 52 attendees and raised \$1,335 that, when added to the income from the August Pool party made a total of \$2,275 raised to date. The members will be taking several days to set up for the annual Holiday Craft Auction being held on December 1, 2023. Evening Holiday Party will be held on December 12, 2023, at Carrabba's Italian Grill on West Charleston. Representative Martinez expressed concern over the motion sensing lighting in the area by the trash container. It does not light up until people are well past it. The issue with be addressed by John King.

Holiday Luncheon Coordinator: Jenny Durant reported that all plans were in place for the Holiday Luncheon being held on December 15, 2023, at the Las Vegas National Golf Club. The event will start with a reception and music at 11:00 am followed by lunch at 12 noon. Jenny is working to get the Jazz Ensemble from Chaparral High School, that performed at our Open Market, to provide the music.

The meeting was adjourned at 11:25 a.m.

each other and raise each other up in power.


