Club's 2024 Rummage Sale a huge success. We had so many hard-working volunteers and so many wonderful donations. We could not have done it without you, your friends, and your families.





What's the Board up to?

Call to order: President, Frankie Chase-Segel, called the meeting to order at 10:00 a.m. with the secretary present.

President's Report: Frankie Chase-Segel praised the Club for excellent and challenging work for the Annual Rummage Sale, with special congratulations to Connie Freeman and Chris White. President Chase-Segel said that most of the meeting will be dominated by the decisions and offerings from the important and hard work Nominations Committee Chaired by Brenda Dupont. She further said how pleased she was to see so many members, new and old, wanting to get more involved in the Club's operation.

Treasurer's Report: Corinne Mewhirter distributed the Profit & Loss Statement and Balance Sheet for February 2024. Treasurer Mewhirter said she had nothing to report but asked that everyone review the financials and let her know if there were questions. She further informed the Board that she had reconciled all numbers with the Financial Secretary. There were no questions.

Financial Secretary: Nancy Zangl distributed the February 2024 Financial report which shows a total income of \$5,039.51, which included \$2,561 raised at the Ways & Means Chinese New Year event. Secretary Zangl then stated that anyone donating \$50.00 and greater should have a Thank You letter/card from Corresponding Secretary. A discussion ensued regarding what to charge new members who join mid-year. It was agreed that the charge was half (\$50) for joining after December.

Corresponding Secretary: Sylvia Phillips reported that she had sent thank you notes to Melody Wells and Linda Baxter for their donations to Ways and Means.

Building Chair: Chairman Cherie Williams-DeWitt. President Chase-Segel read the written report Chairman Williams-DeWitt's submitted. In the report she congratulated all those who helped with the Rummage Sale. It was during this event that a truck severed the telephone line, which has since been repaired. There was also an issue with the Tuf Shed outside. John has scheduled repair. She further reported that the Rummage Sale generated an enormous amount of trash, and that Republic Services will be charging for the extra pick up. She reported that all members had been notified of the rental structure for Members. Chairman Williams-DeWitt then expressed her desire to continue as Building Chair in the 2024-2025 Club year and have a co-chair to collaborate with her to lean the ropes as well as take over the clerical duties of the position.

Community Services: Chairman Chris White passed out flyers to remind the Board of the upcoming "Elegant Afternoon Spring Tea" on April 6th and to request donations of gift cards to be used for the raffle and items for Silent Auction baskets. Chairman White went on to express how well the Rummage Sale went but did not have definite numbers yet. She praised all the hard work done by our Custodian, John King, and made the following motion "I make a motion to pay John King and extra \$100 for his help during the Rummage Sales". The motion was seconded, discussed, and unanimously approved by the Boad. (motion attached)

Evening Representative: Evening Representative, Dolores Martinez, reported that the Evening Ways & Means Super Bowl Bunco was a tremendous success and raised \$1721 despite the less than expected attendance due to the weather. She further reported that the Evening members were looking forward to several social events, including the Oscar Viewing Party on March 10th, supporting the Variety Children's Charity, a tour of the Community Counseling Center on March 12th and the performance of "Cats" at Faith Lutheran School on April 28th. The Evening Nominating Committee is busy compiling names for next year's slate of Evening Chairs. Representative Martinez closed her report by reminding everyone of the upcoming "Derby Day" on May 7th and promised more details would follow.

Ways & Means Committee: Chairman Linda Zesiger reminded the Board of the Ways & Means upcoming fundraiser, "Sipping' Into the Sixties" on March 22nd. She also said how pleased she was the turnout for the Chinese New Year event and wanted to thank everyone for their help.

Community Services Director: Director Cathi Poer reinforced Chairman Chris White's statement regarding donations for the Silent Auction and Gift Cards for the upcoming April tea and encouraged everyone to attend and invite friends and family. Director Poer then went on to tell the Board of a donation of expensive jewelry from a random attendee to the Rummage Sale. Director Poer took the items which included both gold and silver jewelry as well as 2 class rings. The rings were appraised for approximately \$200 each and the other jewelry more than \$1,000. After further review, it will be decided if it should be sold or used for Silent Auction items.

Nominating Committee: Chairman Brenda Dupont distributed copies of the Committee's list of nominees for Officer and Director positions for the next year's election to be presented to the membership at the Closed Business Meeting on Friday, March 15th (see attached). Chairman Dupont went on to make the following recommendations:

- "The nominating committee recommends that the Board approve the nomination of Cheri Williams- DeWitt to run as Building Chair.

 If elected Cherie will be serving the fifth year in that position." After discussion it was decided to vote by secret ballot vote. The final vote count was 5 yea's and 9 nays'; the recommendation was not approved.
- "The Nominating Committee recommends board approval of the nomination of Frankie Segal to run as Building Chair." President Chase-Segel excused herself from the meeting and President-Elect, Dianne Steele oversaw the vote. After discussion it was decided to vote by secret ballot. The final vote count of 12 yeas and 2 nays the recommendation was approved.
- "The Nominating Committee recommends board approval of the nomination of Director Barbara Bolling to serve an additional twoyear term as Director."

After discussion, the recommendation was approved by a unanimous decision. Chairman Dupont then announced the nine persons (attached) being nominated to run for members of the Nominating Committee. After discussion, it was decided that 2 of the names be removed because they had already served on this Committee. There are 8 names on the revised list (attached), however nominations from the floor will be open until the day of the election and any nominated individual must have consented to be nominated and meet by-law eligibility requirements.

The meeting was adjourned at 11:23 a.m.




Getting this newsletter done is a source of keeping me busy. Please enjoy.
