# Charges

- Matters:
- Prosecution of Jawaad Abdul Ali & Amir Mansur Ali
- Violations Set forth:
  - 1) Unlawfully Acting as an Aboriginal Jurist without certification contract or rights
  - 2) Unlawfully coercing another national to participate in unlawfully nationalizing new nationals
  - 3) Theft of nationality/Dues funds from ARNA Headquarters and ARNA nationals
  - 4) Selling non natural mucous producing foods to nationals for Profit
- AMIR
  - 1) Violating Private Irrevocable Trust Agreement
  - 2) Attacking the Integrity of ARNA Constitution and Institutions without authority
  - 3) Theft of ARNA Property-refusal to return
  - 4) Threats that Chief Ali will be killed for his actions
  - 5) Not following dietary law, too sick to operate as Chief of ARNA
- Defendant has plead guilty to all charges
- Prosecuting party will provide proofs of all of the above four issues
- and settlement is in order unless Defendant Jawaad Abdul Ali changes and revokes confession.

# Injured Parties

- To date 71 Nationals received incorrect documents missing IDS and or no EIN Business Access in violation process
- Receipts for the payments to Jawaad Abdul Ali have been sent to a private email from each reporting national
- Proof Jawaad Abdul Ali had no access to proper documents.
- 
- of the 71 injured 5 had paid via proper process to ARNA and were confused about intake process
- 66 dealt directly with Jawaad Abdul Ali and Amir Mansur Ali in some form or fashion
- $66 \times 360 = 23,760\$$

# Injured Parties

- Headquarters has commenced remedying the injured national who was coerced by Jawaad and all 66 injured new entries.
- Funds will be used to:
- 1) Give all 66 nationals proper EIN and Business Article Service directly from headquarters:
- 160\$ per national totaling 10,560\$
- 2) Correct Documents for each national with assistance of jurists who will be paid 120\$ per packet to correct the issue.  $66 \times 120 = 7,920\$$
- 3) Ensuring every national in the 66 have the correct IDS in full (Both Sets) with Proper information on each ID including proper addresses ID # Coding which was a classified technique Tax Exempt Number signature/Autograph, with proper passport photo and Proper submission of intake online. ARNA Aboriginal Law Firm has paid for the service of online intake registration for all 66 of the unlisted nationals. Websites have been updated.
- ID Service is  $80\$ \times 66 = 5,280\$$ .

#### **Official Notice to Nationals of Aboriginal Republic of North America**

Notes:

Week 1 Parties showed up late (ALL). This is THE most important course to get the government prepared to go to the next stage and all parties had notice a month in advance

Week 2- Parties showed up late again- Homework not completed

We are now on week 3 and we are showing WHY ARNA is in the shape its in. We are not taking our coursework serious enough to lead and BUILD TEAM. So as the orchestrator of the Decree for Rites of passage and the Organizer of the coursework and in my regnal position according to decree the following must occur:

1) All Officers in the Government certification course MUST complete Assignment 1-Writing the entire ARNA Constitution one time in a notebook.

- Any Constitutional delegation of the authority of these listed entities (If they are socio-political constructs within ARNA Constitution) their processes operations etc... is subject to this agreement and any original copyrights trademarks or patents of Chief Amaru Namaa Taga Xi Ali Muhammad or a delegated entity.

# Agreement Supremacy Clause

- Paragraph 10
- All subsequent rules concerning this Irrevocable Trust Agreement & General Obligation Bond and all others issued henceforth will be drafted by Xi Global Trust Trustees and administrators and issued to the Head of Government of ARNA or delegated political authority of ARNA and appointed cabinet for the fiscal year period of ARNA. No Irrevocable Trust Agreement and General Obligation Bond issued by Xi Global Trust et al can be rejected by any political official of ARNA.

# Deciding Power in Dispute

- Paragraph 11
- In the event of any operational challenges to the legitimacy of these bonds or their operations or continued operations arises a sealed arbitration group operation is the only remedial measure that can be taken and must consist only of the Head of State, former Heads of State, Trustees and administrators of Xi Global Trust. Parties will have 72 hours to make a final decree. If no decree is met all decisions will be decided by the Trustee of Xi Global Trust who must operate as a former Head of State or specific rites of passage official under all conditions.

# Annulment of Position Clause

- Paragraph 3 Annulment of Position
- All parties within this agreement and subsequent agreements must complete all rites of passage requirements. Failure to do so will annul the position authority and rights of the party in respect to this instrument yet does not annul cancel rescind or impact the authority of the instrument itself.

# Disclosure Rules

- Paragraph 4
- The only condition upon which this agreement can be disclosed is in any event that it necessarily serves as a proof of the binding agreements of ARNA with Xi Global Trust et al for the purpose of the security of continued governmental operations pursuant to the original design of the government and any need for the safety of maintaining the operations and natural order of the government.
