**Initial Brief In Charges against Amisi Ola Xi Amaru**

**Summary of Action**

On 8-26-2024 a Plea Deal was offered to Defendant Amisi Ola Xi Amaru. Amisi Ola Xi-Amaru rejected the Plea Deal on 8-28-2024.

This is her direct statement from email.

On Aug 28, 2024, at 4:03 PM, Tasha [REDACTED] wrote:

***I'm NOT taking a Plea deal. I have absolute proof that all [REDACTED] reached out to me. [REDACTED] reached out to me thru IG messenger. [REDACTED] also reached out to me as well. My question is why haven't any done anything about [REDACTED] case? I never call [REDACTED] reached out to me. I wouldn't have known anything was going on in [REDACTED] household. Let's go! I've done nothing. Start the trail.***

This was the details of the plea deal,

"This Plea deal is Offered from the ARNA Xi Amaru Government to 'defendant' in an attempt to avoid an actual trial and settle the matters in an efficient manner. The Prosecutor asserts it has evidence of the following breaches of Parties.

Amisi Ola Xi Amaru

- 1) Eavesdropping with result of harm to my family.
- 2) Gossip with result harm to my family
- 3) Acting deceitfully with result of causing harm to my family
- 4) Causing unjust grief to others

5) Causing disruption of peace of my family

### **UPDATED EVENTS IN SUMMARY**

On July 31<sup>st</sup> 2024 Amisi Ola Xi Amaru received a Message from [REDACTED]. The message was an inquiry on if [REDACTED] was going to the summit 2024 in Atlanta GA. Amisi is a resident of [REDACTED]. [REDACTED] also asked if [REDACTED] was 'going with anyone'. Amisi Ola returned response and asked is [REDACTED] was attending. [REDACTED] responded did not know but didn't want to attend 'as a third wheel'.

The conversation itself appears simple. The issue is HOW I RECEIVED IT. I received it on August 11<sup>th</sup> 2024 at 1:13 pm EST from [REDACTED] I was formerly married to under a mainrenance contract. [REDACTED] emailed it to me. [REDACTED] received it from Amisi Ola Xi Amaru in a gossip exchange.

Amisi Ola has acted unjustly. Her actions are not only violations of our moral code but highly suspicious as in the actions show her TARGETING my past or present family members.

She has stated directly to [REDACTED] after attending my birthday gathering [REDACTED] that she thought [REDACTED] was jealous of [REDACTED]).

Amisi Ola Xi Amaru is targeting of my family members and committing the acts mentioned above in points 1-5 have caused an offer of a plea deal which she has refused.

Amisi Ola Xi Amaru [REDACTED] sent a voice message that was captured by the [REDACTED]. [REDACTED] I have shared that message with Jural Society. [REDACTED] threatened to come and cause me physical harm in the message. According to Intell the pre [REDACTED] was a post I made on IG which was a post about our men privately protecting our families and insinuating if they (our enemies) take our best we should take theirs. This post absolutely had nothing to do with Amisi Ola Xi Amaru and I don't even know her family, besides a granddaughter [REDACTED].

The issue here is simple. Amisi Ola is a 63-year old, single woman, national. She has [REDACTED]. Women coming to her to get advice is NOT a violation. Spreading the womens messages from one woman to another without those women being aware caused gossip and chaos from that gossip. For the protection of the women involved I barred them from coming to the Summit. Either one of them could have been endangered by her (AMisi Ola Xi Amaru) unlawfully gossiping with one [REDACTED] and telling her about the actions and potential travel without authorization from that [REDACTED].

Based on the fact that Amisi Ola Xi Amaru has caused the potential endangerment of the Chief of the Aboriginal Republic of North America, without any merit, and based on the fact that she 100% took [REDACTED] messages about where [REDACTED] was gonna potentially be and shared it with another [REDACTED] who does NOT like [REDACTED]. I am requesting the Remedy explained below for the listed violations.

6. I have not acted deceitfully

17. I have not been an eavesdropper/gossiper

27. I have not caused Disruption of peace

18. I have not falsely accused anyone

### **Request for Remedy.**

I Am demanding Amisi Ola Xi Amaru be expatriated involuntarily from the ARNA Xi Amaru Tribal Jurisdiction.

The grounds for this expulsion and expatriation are:

Her actions are so gross and emotionally unbalanced that she has involved her other family members in a potential war that could lead to physical death.

Her behavior exhibits that she will IMPULSIVELY and DELUSIONALLY infer that I am talking about her online without any evidence.

She also will spread gossip and cause division amongst the wives and family members of officials giving private intel on the potential whereabouts of sisters, without their consent.

Amisi Ola Xi Amaru has visited one of my private inhabitations. So she could share that information with family members again causing potential harm to them if they were to appear anywhere near me.

Her actions show she is unconcerned with sisterhood, family, or causing others physical harm.

My question to any dissenter on a jury or the jural society is,

What purpose does Amisi Ola Xi Amaru serve in ARNA Xi Amaru Tribal government at this point?

Is keeping this type of national amongst us safe.

If there was a lighter punitive action and she is totally unapologetic and she is again, no transformation would take place. She is unfit to be a tribal member of our Indigenous Government and I ask the National Jural Society to consider immediate expatriation and cancellation of all

contracts for the safety of myself, my family, and anyone else who could have a similar interface with this person.
