For the record:

The Chief Executive may participate in the affairs of the NJS Court pursuant to ARNA Constitutional Law, but as prosecutor he does not determine the granting or denial of motions and requests to the Court, the NJS Judges do that.

The majority of members voted to allow the continuance but for a shorter time frame than requested. On one hand, if the allegations are false, the Defendant will be harmed due to his public reputation being tarnished for an even longer period of time, and his economy being hurt by his jurist capacity being stopped for the extended length of time. On the other hand, if the allegations are true, the potential for the Defendant to commit further alleged harm is too great for the Court to allow for several months further. So, both parties can potentially be prejudiced/injured by these pleadings being delayed. Another point I brought up to the NJS is that this may be a good period to bring an end (9 of Spades) to this dispute (Mars) as a family/brotherhood (8 of Hearts) if the energies are utilized in that direction.

Full disclosure: I left the NJS because I no longer wanted to be a part of the incompetent and negligent Court that was in place. I aim to stay on the right side of history, so I left. All of the available NJS Members voted against my indictment against Min. Arkan that day other than Min. Trazell, and Min. Rashad never casted a vote to my knowledge. I was bothered by the group failing to act in defense of ARNA and our Constitution in that matter, and it was the culmination of that and several similar instances of negligence or incompetence over the years that led to my decision to remove myself. I only agreed to accept the role as NJS President b/c in that position I can now halt the negligent and incompetent behavior that may go on for the duration of this term (which isn't much longer with the elections coming up soon).

I never stated that you (Ansâr) would back Arkan b/c you are both members of the Nation of Islam, you actually alleged that particular connection to him in the meeting on 9.17.23. I stated that "you and Arkan are very close, so, I understand that you're not going to convict him. Because like, you're his friend. I think you care more about your friendship with him maybe than, certain things with like our duties to, you know, the integrity of our Nation, the Constitution. I don't really trip off that, I know who everybody is and where we stand." I was also in the Nation of Islam Mosque No. 45 in Houston, for a very short time (about 3 months), but I could see how that connection btw you two could also be apart of my assertion that you have a certain rapport that would make you defend him over siding with my claims against him. And that accusation/assertion was never cleared up, no fact-finding investigations into your relationship with Arkan were done and submitted to the NJS record, it's just your word against mine on that point at this time.

I think you (Ansâr) made a bad judgement as to Arkan's character and his intentions, but I don't know if you are a thief scheming to steal funds from ARNA or infringing on ARNA copyrighted materials as has been alleged against you. The evidence presented by the prosecution would have to prove that to me before I can cast judgement in this case. The presumption is that you are innocent until proven guilty.

I am responding to your motion to recuse as honestly as I can, because I don't want anymore Defendants in our court potentially claiming biases in the event that a case does not go in their favor. The Court has to maintain impartiality and fairness or else it's worth nothing.

All that being said, I will genuinely consider recusing myself as I do understand your concerns.

And you need to specify which Judges you want to be recused. I know I am one of them, but who are the other 4 you are referring to? I see where you have stated that all are biased except one.

The deadline to answer the plea offer is 11:59pm EST, September 19th, 2024. Failure to comply with the Order may result in findings of contempt, default in answering the pleadings, and a presumption arising of rejection of the plea offer.
