Expedited request:

Prosecutor requested expedited response from Defendant and arbitration from the NJS as the matter concerns high potential for continuous attacks upon my family members and disruption of my home and operations:

Prosecutor request a response from Defendants within 3 days or allow for immediate trial on the matters as we believe that the matter can be handled expeditiously and closed.

If Parties fail to respond prosecutor is prepared to engage all of the claims with evidenced proofs of each claim above.

Terms

Formal Public Apology to the women of ARNA for violation of moral code (All five points listed above).

Removal from any and all Aboriginal university Credentials with a 3 month suspension.

Probation for 3 months ARNA Xi-Amaru Tribal Government under which terms any infractions or ARNA Moral Code or laws actions will nullify the plea deal and resort to ad additional year of probation and extended 1 year suspension from Aboriginal University.

3 month ban from all DOS Activity.

1 Year removal of voting rights

If this agreement is not accepted Prosecution requests trial by expedited request above.

By Entering this Plea agreement, the parties are willing to take the recommendations of the Prosecution/Chief Execitive and the agreement of the ARNA National Jural Society to resolve this matter permanently. Defendant agrees to follow the stipulations provided in this agreement. If any clauses of the plea deal are breached the deal will be revoked and a new plea deal will be required with additional penalties provided above.
