Summary:

This response to Amisi Ola Xi Amaru claims comes as a result of her filing claims based on allegations made by her and allegedly by [REDACTED]. I have organized the complaint into an affidavit and responded to the claim. I had already submitted this response. I am just officially reorganizing the response upon direction by ARNA NJS that this is a separate case. I do not have a case number for it so I will follow any case annotations provided by ARNA NJS.  
Affidavit of Amisi Ola Xi Amaru

- 1) Dr. Ali's behavior is a clear reflection of unresolved mommy issues. His deep-seated resentment toward women is evident in the way he manipulates, abuses, and discards them, proving he's more concerned with his ego than with the well being of anyone else.

Amisi Ola does not know my mother. She has no idea on any level the extent of my relationship with my mother and so her false assertion is heresy and this pattern has been present since she falsely claimed from posts that I threatened her and her delusional ideas about me will become evident. Amisi Ola Xi Amaru believes I have a deep seeded resentment towards women because I shared a video from a woman on social media that was titled "women over 35 should settle". She expressed her disdain for the video and we inboxed where she stated she disliked my views. By this time, she had already gossiped about me. (See Attachment Exhibit 1 Chief Ali Amisi Ola Inboxes on facebook July 29<sup>th</sup>. This was BEFORE [REDACTED] asked her about the Summit. This was BEFORE she shared [REDACTED] text messages with [REDACTED]. So now we SEE Motive. This has nothing to do with my ego. You don't like my opinion as a man about older stubborn women and you took the post PERSONAL.

- 2) Nama Taga Xi Ali has become increasingly hostile ever since I discovered the full extent of his long term abuse toward [REDACTED]. I am not hostile towards Amisi Ola. That is a matter of opinion. I addressed her direct in private and public BEFORE she shared messages [REDACTED] snet her (Amisi) with [REDACTED]. I filed charges. That's not hostility, that's seeking justice.

- 3) Over the years, this abuse mental, emotional, verbal, and physical has created a toxic and destructive environment.

[REDACTED] has for 4 years since [REDACTED] been taken care of by me. [REDACTED] has been given financial opportunities, social advancement, been physically nurtured, introduced to my direct family [REDACTED] etc. [REDACTED] posts one sided stories on the internet whenever [REDACTED] cant get [REDACTED] way. [REDACTED] was mad I would not let [REDACTED] attend the summit. [REDACTED] was not put out. [REDACTED] will testify I ubered [REDACTED] HOME to [REDACTED] which I have receipt of. We had no arguments going on. [REDACTED] was going home to prepare products, see [REDACTED] and take care of business items. I have official [REDACTED] [REDACTED] IS NOT HOMELESS. [REDACTED] lied to Amisi Ola. [REDACTED] lied online. This is what happens when someone is delusional and believes things without proof. If [REDACTED] has evidence that [REDACTED] does not have an [REDACTED] in [REDACTED] let Amisi Ola bring actual proofs. I demand those actual proofs be listed in her response. The only claims Amisi Ola is making is based on statements from a [REDACTED] who is not making any statements to this court [REDACTED] yet. Amisi Ola is to ignorant to know, THAT'S NOT PROOF

- 4) [REDACTED] bravely reached out to me in July through Messenger, sharing the torment [REDACTED] has endured under Ali's control. Until then, I had no idea about the years of suffering [REDACTED] had been subjected to.

Heresay. Amisi Ola will have to bring the witness forth with evidence of the claims and allow for me to rebut each claim with my own evidence of the cause of any arguments, disagreements, and issues between myself and [REDACTED]. I have those proofs and will gladly bring them to the ARNA NJS in my defense.

5) Now, with videos and screenshots as evidence, I am fully aware of the severity of A's abusive behavior. When I first heard from [REDACTED] I immediately reached out to [REDACTED] to gain some clarity on the situation.

Another breach. Amisi Ola reached out to her family member [REDACTED] is an [REDACTED] but not the [REDACTED] that deals with court matters. Also I have the evidence that [REDACTED] asked Amisi Ola NOT to take that action.

6) [REDACTED] was under the impression that Ali had ended his relationship with [REDACTED] and was unaware that [REDACTED] was still present in his life. It's important to note that [REDACTED] came to me first, seeking help, and I have the proof of her initial outreach.

[REDACTED] reaching out to Amisi Ola is not a crime

7) Beyond his abusive behavior towards [REDACTED] Ali has proven to be an egotistical and hypocritical individual who consistently disrespects others within the tribe.

I have no cases filed against me for disrespecting tribal members. I have not been charged with disrespect or convicted of disrespect. If I have said anything directly to someone or online it was ALWYS in self defense and I am willing to bring any and all receipts if defendant brings particular claims

8) He has made several offensive posts about Me and [REDACTED] publicly gossiping and making derogatory remarks about other tribal members in the comment sections of his posts.

The posts I made about Amisi Ola were AFTER I gathered the evidence of her causing disruptions in my family by attempting intentionally to divide [REDACTED] and then attempting to lie to her [REDACTED] who threatened my life. I was in the right to defend myself in my analysis of our laws and if this defendant puts these accusations in a separate lawsuit, as procedurally required I will answer point for point with evidence

9) Rather than upholding the values and integrity expected of someone in his position, Ali has aligned himself with known scammers like [REDACTED] further tarnishing his reputation within the community.

I have absolutely no alignments with [REDACTED] at all. In fact the last time I communicated with [REDACTED] is was actually TO GET JUSTICE FOR AMISI OLA Here is the inbox I sent [REDACTED] so Amisi Ola could get justice ([SEE EXHIBIT 2](#))

10) It's not just gossip that surrounds him his actions go directly against tribal code.

Heresay. Defendant is not pointing out any actions. She's pointing out beliefs that have nothing to do with her answering to charges against her

11) According to [REDACTED] he has invited a woman who practices witchcraft into his home, allowing her to perform spells on members of the tribe. One such incident involved the use of a rooster in these harmful rituals, for which we also have evidence.

This is actually funny. I don't even advocate or believe in that spooky stuff. Noone has ever done any rituals in my home but pray. There is no evidence of anyone doing rituals. I have not even seen a rooster in years and certainly have not used one in any spooky rituals. Defendant must bring evidence of this or use [REDACTED] a witness once the case is filed to prove this heresay and false allegation.

12) His behavior is not only disturbing, but it also demonstrates that Dr. Ali is not a good role model or a figure that tribal families should look up to. His blatant disregard for the values of the tribe is why I refused to accept any plea deal in the case involving him;

Defendant must actually show evidence. Families look up to me because of my behavior. Of course they might not agree with everything I say or do and that's not required in ARNA. My duty is to execute the duties of Chief Executive and to follow the law. I do that to the best of my ability. If someone makes a claim I am not doing that my duty is to defend myself, thus this response with evidence.

13) I will not falsely admit to claims that are simply not true, especially when it is he who has abused his power and authority.

It is TRUE that Amisi Ola Xi-Amaru sent messages from [REDACTED] that were private, between Amisi Ola and [REDACTED] to [REDACTED] That is what evidence is on the table. Amisi Ola Xi Amaru not one time has stated she did not send the messages. She hasn't stated she didn't commit that breach of moral code once, not in any email, any response, etc

14) It is troubling that, despite his position, Ali has made no meaningful efforts to address the issues plaguing the Arna members, many of tribal members financially struggling.



If families are financially struggling the duty of the Chief Executive is to address it via Hardship applications for dues, and to use Aboriginal University to build entrepreneurship. If Amisi Ola Xi Amaru wants SNAP or Welfare she can apply via the US federal Government. The statement shows Amisi Ola thinks I personally owe nationals money because we collect dues.

15) My [REDACTED] has sought comfort and support from the Arna community, only to be met with more deception by people like [REDACTED]

I have no knowledge of this claim

16) Ali accuses me of gossiping about him, yet it is his actions abusing multiple women and aligning himself with immoral individuals that is the real problem.

Defendant has alleged I am aligned with [REDACTED] I am not. I am not sure who else she may be discussing but defendant continues here heresay and delusional conclusions.

17) There are even serious allegations that he was involved with someone he believed to be a woman, but who, according to [REDACTED] was not.

This is funny. She is talking about [REDACTED], a woman I courted in 2021. [REDACTED] is DEFINITELY a woman. My accusation against [REDACTED] was that she had surgeries that she was hiding and had another identity. It is a fact that she did and does, yet I allowed that tense interaction to settle in peace. I did that because of the serious security issues that situation posed. [REDACTED] believed that [REDACTED] was not a woman and she used to joke about that. She was jealous of [REDACTED] as far as I understood. This statement is a long list of delusions that Amisi and [REDACTED] are engaged in.

18) Such behavior is completely against our tribal code and is morally wrong. Ali's failure to uphold the values of respect, honor, and integrity only adds to the harm he has already caused. He continues to project his faults onto others, distracting from his own wrongdoings, but the truth is clear his actions have violated the trust and values of our community, and he has repeatedly failed to take responsibility for the harm he has caused.

I have not repeated anything but if someone brings accusations in this court I have never ignored them. This is the forum we agree to by contract to appear in and bring charges allegations and support them with evidence. This court has no record of me ignoring its authority.

19) What makes this situation even more alarming is the way Ali has involved others in his schemes

20) [REDACTED] messaged me on Instagram, casually asking if I was going to the Summit. This struck me as odd since I had never mentioned anything to [REDACTED] about [REDACTED] or Ali.

Provide supporting evidence

21) Then, out of nowhere, [REDACTED] called me through Messenger, pretending to be concerned after seeing a post I made. [REDACTED] has never shown any real interest in my posts before, so [REDACTED] sudden "concern" was clearly orchestrated by Ali.

Actually [REDACTED] lied to me and said you messaged [REDACTED] asking why [REDACTED] didn't like your post. I have communicated to [REDACTED] that [REDACTED] should not lie to me about these things because [REDACTED] DID LIE. I was nowhere near [REDACTED] and orchestrated nothing because I never knew a call happened because I was lied to. If called as a witness once this other case is filed I have evidence via text, I never orchestrated a call from [REDACTED] to Amisi Ola

22) He undoubtedly instructed [REDACTED] to reach out, adding to the layers of manipulation.

Absolutely false. I did not and [REDACTED] can testify that [REDACTED] failed to share that with me and lied about the situation claiming you contacted [REDACTED]

23) Just recently, [REDACTED] also texted me, asking if I was okay, but I didn't respond because I see through the petty immature mess that's unfolding.

I cannot affirm or deny this statement

24) Nama Taga Xi Ali has been working tirelessly to maintain a facade of righteousness, portraying himself as a figure of wisdom and authority. But the reality is far from the image he tries to project.

I am honest, respectful to those respectful to me and loyal and anyone can make a claim against that but they must bring evidence. I don't care if someone sees me as wise or not and in this capacity I am orchestrating authority in my officership in government

25) Behind this mask, Ali is a manipulator, an abuser who has preyed on vulnerable women like [REDACTED] using his power, influence, and financial control to exploit and dominate them.

False. I give any woman im contracted to opportunity for entrepreneurialship, agreed upon financial support, ability to travel via an automobile, love, communication and an oath. If someone violates that oath then we may have problems arguments etc. Seeing a post of a video or text of onesided views is not evidence that can convict. These things must be reviewed in totality and to allow our courts to review them and come to conclusions.

26) Ali's actions go beyond mere emotional manipulation he uses his financial resources to further tighten his grip on these women, knowing they have little choice but to comply.

I met [REDACTED] when [REDACTED] was [REDACTED]. [REDACTED] had already raised [REDACTED] worked in life, and taken care of [REDACTED] I met [REDACTED] at [REDACTED] [REDACTED] was in a relationship with a former ARNA National. I met [REDACTED] again at [REDACTED] and we began to court and went under a maintenance contract with the intention to marry. I had no control over any women. I never physically or emotionally abused any women. Yes I argued with them and we have disagreements. That is normal. I can show evidence of the source and origin of every disagreement to this court when other cases get filed.

27) [REDACTED] for example has been kicked out of his home multiple times, left homeless because Ali wanted to invite random women into his house women with questionable motives

Absolutely false. [REDACTED] was Always driven home to [REDACTED] or sent via Uber, flight or bus which I have receipt of. The 1 time I refused to pay for [REDACTED] [REDACTED] had just been paid for work, refused to leave upon request and thus I didn't pay and that was 1 time only and I knew [REDACTED] had money because I had paid [REDACTED] is not and has NEVER been homeless. Amisi Ola is just not aware of these facts but a properly filed case which is coming will reveal these things for court record.

28) Is this what we should call moral leadership? Is it acceptable for someone in his position to treat women this way?

Heresay and delusion

29) Kicking [REDACTED] out and leaving [REDACTED] in a vulnerable situation is not just against moral code, it's against basic human decency. And yet, Ali continues to exploit his authority to silence anyone who dares to speak out.

Again [REDACTED] was sent home in an uber this last time and we were not even arguing. That argument came about over her posting [REDACTED], a known enemy of mines and I addressed [REDACTED] on it which led to an argument. [REDACTED] was HOME [REDACTED] which is hwere the Uber dropped [REDACTED] off at ON RECORD. [REDACTED] is not homeless.

30) Despite the evidence of his actions, Ali will likely try to portray himself as the victim, painting me as the troublemaker and attempting to manipulate others into believing that he is a good and honorable man.

Heresay, actions will tell who IS NOT ADDRESSING THE CLAIMS. Its Amaisi Ola. She IS NOT addressing the claims against her

31) But this is a diversionary tactic a ploy to distract from the fact that he is an abuser.

Heresay. Amisi Ola will have to bring the witness forth with evidence of the claims and allow for me to rebut each claim with my own evidence of the cause of any arguments, disagreements, and issues between myself and [REDACTED] I have those proofs and will gladly bring them to the ARNA NJS in my defense.

32) [REDACTED] is not the only woman he has manipulated This is a pattern, one that has repeated itself with countless other women who are too afraid to speak out because of the power Ali wields over them. He uses his financial control, his standing in ARNA, and his carefully curated public persona to keep these women silenced and trapped.

Anyone who knows my history I have a few PUBLIC wars with women. Lol, they ARE NOT AFRAID TO SPEAK OUT. Even if I consider their allegations false, they definitely speak out. One of the reasons they speak out is because THEY ARE NOT AFRAID

33) To be perfectly clear, I don't care about being part of ARNA anymore If ARNA cannot protect its women and children if it allows men like Ali to exploit, abuse, and manipulate without consequence then I want no part of it.

This statement is false and heresay

34) What was once supposed to be a tribal government has now turned into something far more dangerous. It is starting to feel less like a community bound by mutual respect and shared values and more like a system designed to protect those in power while ignoring the suffering of the vulnerable.

Heresay once again

35) Ali has repeatedly shown that he does not care about the well-being of the women in ARNA. Instead, he uses his authority to foster dysfunction, triangulating relationships between women and stirring up chaos to keep control.



Amisi Ola is the only one here triangulating women specially [REDACTED] and [REDACTED] and this is why the charges were filed

36) Why should I be prosecuted for assisting and counseling a woman who has been abused? This isn't alleged abuse; it's real, and there is evidence.

You are not being prosecuted for counseling a woman. Read the charges above

37) Yet, the men of ARNA, including [REDACTED] do nothing. They turn a blind eye because Ali is at the head of the organization.

Slander and libel. [REDACTED] has not silenced anyone to my knowledge. Amisi Ola is delusional and attacking people with no evidence

38) Ali claims I'm eavesdropping, but he threatened [REDACTED] forcing her to share our private conversations

I did not threaten [REDACTED] will have to show how I threatened her.

39) He then went on social media, called us names, and even publicly revealed our identities.

Yes I called you names in self defense after you like a wicked backstabber tried to divide [REDACTED] who were in my family. And Mop head refers to that toxic wig you wear that is blocking your ability to transmit good sense.

40) His anger stems from the fact that I know the truth about him and others are starting to realize it as well.

You have delusionally accused me and I am rebutting your claims. I don't care who thinks what. I care about the court and respecting authority thus I am responding.

41) Ali isn't angry because I'm gossiping; he's angry because his carefully constructed facade is beginning to crumble. People are starting to see him for who he truly is: a man who uses his position of power to abuse, manipulate, and control those who are weaker than him.

Heresay

42) If this is the leadership ARNA stands for, then I want no part of it. There needs to be transparency both about where our dues are going and what they are being used for.

We file an Annual report of dues use. We file an annual budget and submit it to Congress and leave it open for public inspection. We don't even collect a lot of dues and EVERY year I have records of my insertion of my private earnings into the ARNA Treasury.

43) Ali has failed in his role as a leader, and it's time for the truth to come out. The women of ARNA deserve better. The community deserves better. And it's time that the men in ARNA, who have stood by in silence for too long, step up and hold Ali accountable for his actions. It deeply saddens me that we have blindly followed Dr. Ali, a man with no real credentials, and that [REDACTED] who also lacks legitimate legal qualifications outside of ARNA, has been allowed to perpetuate this facade.

Amisi Ola Xi Amaru says I have no real credentials but at the same time she JUST TOOK at AMA Doctors class and messaged me for her Certificate. Maybe she has had a change of thought since then. I don't know but to attack our credentialing system is insane since she took a course.

44) My trust in the men of ARNA has been met with nothing but disappointment, stress, and heartbreak. I placed my faith in men like Ali [REDACTED] and other men in Arna believing they would uphold the values of our community and provide genuine support.

Amisi Ola APPEARS to want welfare. She is currently living with a white woman with [REDACTED] and [REDACTED]. She may be upset about her life as a [REDACTED] [REDACTED] and it appears she wants us as men to resolve her life of poor decisions. She has to realize that we are here to do 1 thing. Assess whether she violated the moral code. In my position she did. I provided the exhibits in my Initial brief. If she cannot defeat those claims then she must face punitive action.

45) Instead, I have been met with manipulation and deception, leaving me disillusioned and distressed. It is truly heartbreaking to seek refuge and resources outside of the American government, only to be let down by the very people who should be leading with integrity.

Amisi Ola has no integrity as she too up this courts time to falsely accuse and not address the charges

46) ARNA has devolved into a cult-like environment, lacking proper guidance and leadership, and plagued by misogynistic attitudes.

And that's her real issue. She dislikes that some men have views that differ from her liberal entitlement psychology. They are the misogynists she is discussing in her mind. ARNA is not a cult and to say such is a slander upon any people in our community.

47) Some Men within ARNA, driven by unresolved issues and personal failures, have pitted women against me, further complicating their situations with abusive relationships.

Heresay

48) Despite my efforts to offer comfort and support to victims of Ali's abuse, he will distort the narrative to paint me as the villain. It is a painful irony that in seeking to support those in need, I am vilified, while those who perpetuate the abuse and deceit are protected and elevated.

49) If further proof is needed of these failings, I can provide it. This situation has left me disheartened and questioning the very foundations of ARNA."

"Here's screenshots of [REDACTED] and [REDACTED] contacting me first. [REDACTED] with her fake concern which I did not respond to. Here's some evidence of his abusive ways.

There's more but I could only send 10."

### Addressing the Exhibits

1 [REDACTED] is sending Amisi Ola our private text messages which is illegal unless for a direct court purpose. In this exchange I was addressing [REDACTED] [REDACTED] was addressing me first via text. CONTEXT: I invited a sister [REDACTED] to teach [REDACTED] and [REDACTED] reiki, as i am designing a reiki curriculum. These were supposed to do videos together. I was going to edit those videos as a promo. I have already written the curriculum. The women started to have issues. I was not in the house having sex with them or anything of the nature and they both upon testimony would attest to that. I was sending [REDACTED] [REDACTED] I sent [REDACTED] home first. [REDACTED] stayed a week after this intense exchange and was sent home in an uber. Looking at one part of a text does not tell the whole story. Next: I do not believe in curse words. After I'm attacked my first response is to retreat inside the house or outside. If it continues, then I respond and my response with [REDACTED] is to SEND [REDACTED] HOME. I sent her home in any uber, a week later and we had no issue till she posted a [REDACTED] video.

2 Addressing Evidence 2 Context [REDACTED] an I argued again and she tried to use [REDACTED] as an excuse for [REDACTED] behavior. In distancing the two things I said that had nothing to do with what was occurring and [REDACTED] was victimizing using [REDACTED] death as a crutch for [REDACTED] behavior. [REDACTED] was posting one sided videos and posts to slander me. Amisi Ola had no context to any of this.

3- Addressing Item 3- [REDACTED] wanted me to Uber Eats food which I don't do except sometimes when [REDACTED] are there. I had just went to the grocery store. [REDACTED] refused to cook because [REDACTED] thought I got uber eats for [REDACTED]. I had not. [REDACTED] delusion had [REDACTED] arguing that I gave [REDACTED] Uber eats and not her. [REDACTED] by the way has [REDACTED] own phone and money where [REDACTED] could order Uber eats if that's what [REDACTED] wanted. Her delusion was the issue. My response was COOK. [REDACTED] was called a [REDACTED] because right prior to this thread [REDACTED] was using foul language and I was laughing and repeated it to [REDACTED].

4- This pears to be [REDACTED] reaching out to Amisi.

5 This was a page created by [REDACTED] at a time [REDACTED] falsified posts saying I beat [REDACTED] up and we found that evidence to be public slander libel and defamation. I did not ever touch [REDACTED]. Since then, we have made peace and I have evidence of that as well.

6- [REDACTED] and Amisi Ola messaging. I don't know the context but as stated [REDACTED] lied to me about those exchanges then admitted [REDACTED] lie.

7- This is the post I made saying I was going to mop the floor with [REDACTED] WITH RECEIPTS, meaning in court. [REDACTED] used that post and others to lie to [REDACTED] and gas [REDACTED] up to threaten my life. (I will be filing charges against [REDACTED] too soon)

8- [REDACTED] reaching out to Amisi Ola. Amisi wont didn't share the rest of that message because it shows [REDACTED] was laughing at [REDACTED] and then [REDACTED] turned around and took this same message and shared it with [REDACTED] [REDACTED] didn't show [REDACTED] [REDACTED] was laughing at [REDACTED] [REDACTED] shared [REDACTED] message [REDACTED] in violation of [REDACTED]

9 A Poem I shared online lol and it was funny, no harm there

10- I don't know the context of the screenshot or the claim, but it may have been when [REDACTED] accused me of being the father of [REDACTED] child. [REDACTED] is an ex national. [REDACTED] wanted me to bring [REDACTED] on as a sisterwife. I considered it [REDACTED] then decided no, and so [REDACTED] was accusing me of being that child's father, which is ridiculous because I have never been with [REDACTED] and [REDACTED] is married to the father of her child.
