Request for Restraining Order

Summary:

This action comes as a result of defamation slander and libel being committed by the above defendant.  
Defendant has initiated contacting an ARNA national and communicating false defamation slander and libel against plaintiff

Background of Interaction between Plaintiff and Defendant

Defendant was a friend on social media via IG and YouTube. She would watch my videos posts etc and comment by asking questions etc

Defendant proposed to plaintiff to participate in writing a book about oral health. Plaintiff agreed to write a short summary of a remedy for cavities. Plaintiff wrote the one page remedy and provided it to the Defendant.

Defendant then began emailing plaintiff and [REDACTED] about a project to complete the book. After repeated strange psychologically unstable and disrespectful statements both plaintiff and [REDACTED] declined to participate in the project.  
After this decline Defendant started to harass plaintiff via text email social media and now by slandering plaintiff to an ARNA national [REDACTED].  
[REDACTED] shared the messages as proofs to plaintiff

At no time has plaintiff courted Defendant

At no time has plaintiff seen defendant in person

When defendant tried to express her desire to court plaintiff, plaintiff communicated he was not monogamous and not interested.

Affidavit of facts &amp; claims

1. Defendant sent National [REDACTED] defaming slanderous libel messages about Amaru Xi Ali which plaintiff received on 1-24-2025. (see exhibit 1&2 attached).

2. Plaintiff does not know Defendants family and has never had any interactions with any of them.

3. Plaintiff never stole any materials from Defendant. The AMA birth course has only research from AMA and outside sources are sourced properly. Defendant has no midwife doula experience and has no children so the claim is ridiculous

4. In a separate lawsuit plaintiff will detail the harassment false copyright claims and sexual harassment carried out by defendant.

5 Defendant appears to either have a mental health issue or be committing crimes of defamation to adversely impact plaintiff.

6. Plaintiff places burden of proof on defendant to prove via evidence and proofs that plaintiff contacted her family members. Plaintiff places burden of proof on defendant to prove plaintiff copied any material of hers.

Remedy Request

1. Plaintiff requests this court to provide a temporary restraining order upon defendant with these stipulations

A) Defendant cannot contact any nationals of ARNA IPA or any other person making false claims against plaintiff.

B) Defendant cannot harass any ARNA or IPA national with messages about Plaintiff

C) If found guilty of defamation slander libel and lying in violation of our moral code in IPA laws and applicable ARNA laws that Defendant must make a video apology and written apology which must be posted to ARNA online groups her social media and to anyone she contacted spreading defamation.

2. Plaintiff demands a fine of 1000\$ on defendant if found guilty of lying on plaintiff. This fine should be delivered to the ARNA NJS, then delivered to plaintiff. If 1000\$ is not accepted then the Jural society should set an appropriate fine fee.

3. Plaintiff requests the defendant be placed on 6 months probation during which she cannot violate any indigenous laws of IPA or ARNA.

4 Plaintiff requests that defendant be required to take a mental health evaluation by the Ministry of Indigenous Psychology Head so that her chart is assessed for probable aspects that indicate mental health problems and that defendant must pay the fee for the assessment.

6. Plaintiff requests defendant be barred from counting in any form plaintiff's family or any ARNA events during the 6 month probation.

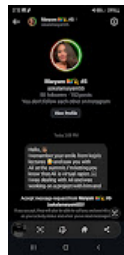
