Motion for Default Judgment

Summary:

Defendant Alsisi Ola Xi Amaru has failed to respond to the Actions of the Plaintiff against her in this case. The response deadline was 9-6-2024, by the order of this court. She instead ,decided to file a separate complaint.

These are the issues the defendant failed to respond to in this case:

Amisi Ola Xi Amaru charges

- 1) Eavesdropping with result of harm to my family.
- 2) Gossip with result harm to my family
- 3) Acting deceitfully with result of causing harm to my family
- 4) Causing unjust grief to others
- 5) Causing disruption of peace of my family

Moral Code violations

6. I have not acted deceitfully (Amisi Ola Xi Amaru acted deceitfully by sharing [REDACTED] messages with [REDACTED]. Amisi Ola acted deceitfully by making her [REDACTED] believe I threatened to harm her.

17. I have not been an eavesdropper/gossiper Amisi Ola Xi Amaru gossiped by sharing [REDACTED] messages with [REDACTED]. Amisi Ola gossiped by sharing [REDACTED] messages with [REDACTED]. According to [REDACTED] [REDACTED] asked Amisi NOT TO SHARE THEM.

27. I have not caused Disruption of peace Amisi Ola Xi Amaru caused disruption of peace amongst [REDACTED] and my family. She could have brought this issue directly to the Jural Society, which is the lawful venue to settle disputes by arbitration of court.

18. I have not falsely accused anyone Amisi Ola Xi Amaru has falsely accused me of things she has no evidence of and I will also answer other aspects of her affidavit below.

Remedy Demand

1. In plaintiff's initial case, the demand requested was expatriation. I am officially amending the request for remedy to the following:
 - a) Defendant must privately apologize to [REDACTED] for sharing [REDACTED] messages with [REDACTED] and provide proof to the ARNA NJS and the Plaintiff that [REDACTED] received the message.
 - b) Defendant must do 30 hours of community service for DOS as designated by DOS head facilitator officials (not including [REDACTED]).
 - c) Defendant must make a video with the following apology to the sisterhood of ARNA (DOS): ***I Amisi Ola Xi Amaru violated the moral code of my government. I apologize to the sisterhood of ARNA for my actions and I respect the decisions of the ARNA national Jural Society concerning this matter. I Apologize to Ali for carrying out an act that added division between [REDACTED] who were under his care.*** This video must be delivered to the ARNA NJS and Chief Executive and will be posted in the ARNA Facebook group, and DOS group.
 - d) Defendant will serve a 3 month probation where she will not engage any of the above violations amongst the women of ARNA.

I request that the ARNA National Jural Society expedite remedy for this case.
