Re: Cease and Desist – Order To Comply

Greetings Ansâr El Muhammad & all Indigenous Businesses Associated,

You have a pending case with ARNA and the National Jural Society. To prevent any issues with utilizing credentials for the time being until the case is settled we will need some things to be completed below.

Effective immediately, you are hereby ordered to:

- 1. **Refrain from performing any duties or functions** associated with the role of a tribal jurist, tribal lawyer including but not limited to Nationalization, ID Distribution, Debt Discharge, Business Registration, Genealogy, Tax Exemption, Power Of Attorney Drafting, Authenticating Documents, Chapter 7 Discharge, Letters Of Regatory, Drafting Up Lawsuits, presiding over cases, issuing rulings, or providing legal opinions on behalf of the ARNA and IPA. Including Services listed on https://www.arnagovernment.org/jurist-contacts--fee-cost-page.html
- 2. **Return all items and materials** related to the position of a tribal jurist, including but not limited to Stamps, seals, identification cards maker, legal documents, seals, or any other property or insignia that may imply official authority or association with the Aboriginal Law Firm as a Tribal Jurist.

These items must be returned to 3900 Crown RD SE Suite 162656 Atlan Nohol Atlanta Georgia 30304 within 30 days of receiving this notice.





Consequences of Non-Compliance:

Failure to comply with this demand, including returning the specified items, may result in legal action being taken against you by the National Jural Society and Aboriginal Republic Of North America, including but not limited to criminal prosecution, Expatriation, civil litigation, and the enforcement of this Cease and Desist order.

Please confirm in writing within 5 days of receipt of this letter that you have complied with these demands, including the return of all items. Failure to respond or continued unauthorized activities will compel us to take further legal action.

We trust that you will respect this notice and act accordingly to avoid any further legal complications.
