## Information about Membership in the Kennel Club of Anne Arundel (KCAA)

**Fees.** Starting in 2024 the dues are:

<b>Individual</b>	<b>\$20</b>	<b>Junior</b>	<b>\$0</b>
<b>Household</b>	<b>\$35</b>	<b>Associate</b>	<b>\$15</b>

**Individual membership.** Individual membership is for a single member aged 18 years or older. These members enjoy all privileges including voting rights and holding office in KCAA.

**Household (Dual) membership.** A household membership is for up to two persons who are both 18 years or older and who live at the same residence. Both members enjoy all club privileges including voting rights and holding an office of the club. Children under the age of 18 must adopt junior memberships. Adult dependents (18 or over) may opt for either the individual or associate membership.

**Junior membership.** Any person who has not attained 18 years of age (see below\*) may apply for Junior membership and enjoy all club privileges, except voting rights and holding an office of the club. At age 18, a Junior membership may automatically

convert to an Individual membership. Junior members must have a parent/guardian or close relative as an Individual or Dual (Household) member of KCAA, and the Junior member should assist the Club with at least one Club event or activity over the course of a calendar year. Each Junior member must complete a separate application for membership.

**Associate membership.** This type of membership is the same as that for Individual membership, with the exception that this membership type does not include voting rights and the member may not be an officer of the club. Associate membership is available to non-Anne Arundel County residents and to AAC residents who choose to be inactive.

**\*For Junior memberships,** age eligibility and fees are based on the member’s age on January 1<sup>st</sup> of the following year. For example, if a person is seeking or renewing a Junior membership and he/she will become 18 years old in March of the upcoming year, Junior dues will be assessed up to the end of the year he/she turns 18. Regular member privileges start on the 18<sup>th</sup> birthday, even when paying Junior dues.
