All guest riders must be age 21 or older and will be subject to approval by SMGA Board. No guest spots are guaranteed until approval is received.

Guest riders, upon approval, will sign a release of liability and agree to follow all float rider rules of SMGA.

Guest riders will only be allowed to be a guest rider for one year (2021) and will not ever be eligible to be a rider in the future unless they are approved to join SMGA as a regular member.

Guest riders will submit a copy of their driver's license along with the \$60 fee in order to secure their spot. No applications will be accepted and spots will not be assigned until fee is paid and release is signed. Spots are assigned on a first come, first served basis.
