

Privacy Policy

Protecting your private information is our priority. This Statement of Privacy applies to <https://www.healthroots.com>, and The Root Integrated Healing and governs data collection and usage. For the purposes of this Privacy Policy, unless otherwise noted, all references to The Root Integrated Healing include <https://www.healthroots.com> and [healthroots.com](https://www.healthroots.com). The The Root Integrated Healing website is a Professional Services site. By using the The Root Integrated Healing website, you consent to the data practices described in this statement.

Collection of your Personal Information

In order to better provide you with products and services offered, The Root Integrated Healing may collect personally identifiable information, such as your:

- First and Last Name
- E-mail Address
- Phone Number

If you purchase The Root Integrated Healing's products and services, we collect billing and credit card information. This information is used to complete the purchase transaction.

Sharing Information with Third Parties

- Engage in public or peer-reviewed scientific, historical, or statistical research in the public interest that adheres to all other applicable ethics and privacy laws, when our deletion of the information is likely to render impossible or seriously impair the achievement of such research, provided we have obtained your informed consent;

- Comply with an existing legal obligation; or
