Mr. Rhodes replied it is NaCl.

Inter Community Bylaw Enforcement Officer Sam Sidal presented regarding current bylaw operations. Mr. Sidal stated that he is responsible for investigation of alleged bylaw infractions. Bylaw enforcement is primarily driven by complaints, but Mr. Sidal also patrols the Village and speaks with residents if he sees issues. Mr. Sidal stated that though he is authorized to issue fines the main tools used for enforcement at this time are communication based. He further stated if any residents have concerns or complaints to please come to the office to ask questions or fill out a complaint form. He also wished to stress that if there is a complaint regarding bylaws all the information is kept strictly confidential.
