The students are turning down other jobs waiting for the decision and at the last meeting the mayor said it was not certain whether the pool is going to be open. Council needs to know that these students need an answer as soon as possible. Mayor Talarico replied that he hopes they are not waiting on Cache Creek for an answer as far as their summer
